





### **Public Comment Summary**

#### What we heard at stakeholder meetings

- Need a detailed cost breakdown for the entire plan.
- Many strategies aren't technologically feasible.
- The plan will result in job loss and put San Antonio at a competitive disadvantage.
- The plan will negatively impact low-income residents and small business.
- Major employers will leave San Antonio.
- The plan needs to be flexible.

- Draft Plan Update Completed by May 25, 2019
  - o Condense language to increase readability
  - Clarify the intent of the equity framework
  - Adjust and clarify strategies based on feedback
  - Include a new business case for climate action section
  - o Identify barriers or challenges associated with strategies
  - Identify strategies that are a part of current city plans
  - Further elaborate plan implementation and governance
  - Develop public engagement summary
- Engagement 2.0 Through October 2019
  - Engagement approach completed by May 3, 2019
  - Continue meeting with key stakeholders
  - CAAP education and awareness campaign
