ORDINANCE

AUTHORIZING THE ACCEPTANCE OF A DONATION IN AN AMOUNT UP TO \$279,735.00 FROM THE SOUTHWEST TEXAS REGIONAL ADVISORY COUNCIL FOR TRAUMA FOR USE BY THE MOBILE INTEGRATED HEALTHCARE UNIT OF THE EMERGENCY MEDICAL SERVICES DIVISION OF THE SAN ANTONIO FIRE DEPARTMENT TO HELP IMPROVE THE HEALTH AND DAILY ACTIVITIES OF CITIZENS UTILIZING SERVICES AT HAVEN FOR HOPE AND REDUCE ADMISSIONS AND/OR READMISSIONS TO HOSPITAL EMERGENCY ROOMS.; AND APPROVING A PROGRAM BUDGET.

WHEREAS, the Southwest Texas Regional Advisory Council for Trauma (STRAC) has informed the San Antonio Fire Department (SAFD) of its intention to donate funds in an amount up to \$279,735.00 to be used by the Mobile Integrated Healthcare (MIH) Unit of the Emergency Medical Services (EMS) Division of SAFD to help improve the health and daily activities of citizens utilizing services at Haven for Hope and reduce admissions and/or readmissions to hospital Emergency Rooms.; and

WHEREAS, the uses to which the donated funds will be put by the MIH program include salary and benefits, supplies, operational expenses, education and training, equipment, vehicle and communication equipment; use by MIH medics of a fully equipped and response readied small SUV to respond to Haven for Hope in a 911 intercept capacity; and triage of patients in the evening who will receive priority appointments in the morning at the Centro Med Sarah E. Davidson Clinic; and

WHEREAS, no cash or in-kind matching contributions are required; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The donation to the City in an amount up to \$279,735.00 to be used by the Mobile Integrated Healthcare (MIH) Unit of the Emergency Medical Services (EMS) Division of SAFD to help improve the health and daily activities of citizens utilizing services at Haven for Hope and reduce admissions and/or readmissions to hospital Emergency Rooms for the period of January 1, 2019 through December 31, 2019, is hereby accepted.

SECTION 2. A copy of a letter from STRAC to SAFD regarding this donation and setting forth certain specifics regarding the use of the donated funds is attached hereto as **Attachment 1** and made a part hereof for all purposes. The City Manager or his designee, or the Fire Chief or his

designee, are each hereby autholized to execute any and all additional documents necessary to effectuate and evidence the acceptance of the donation and/or perform the programs for which the funds will be used, without further action by the City Council.

SECTION 3. The City Manager or her designee, or the Chief of the San Antonio Fire Department or his designee is hereby authorized to accept funds in an amount up to \$279,735.00 to be used by the Mobile Integrated Healthcare (MIH) Unit of the Emergency Medical Services (EMS) Division of SAFD to help improve the health and daily activities of citizens utilizing services at Haven for Hope and reduce admissions and/or readmissions to hospital Emergency Rooms.

SECTION 4. Fund 29820000 and Internal Order 82000000024 are hereby designated for use in the accounting for the fiscal transaction in the ratification of this donation.

SECTION 5. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer ("DCFO"), City of San Antonio. The DCFO may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 6. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
