The City Council convened in a Regular Meeting. City Clerk Leticia Vacek took the Roll Call noting a quorum with the following Councilmembers present:

PRESENT: 11 - Mayor Nirenberg, Treviño, Hall, Viagran, Saldaña, Gonzales, Brockhouse, Sandoval, Pelaez, Courage, and Perry

- 1. The Invocation was delivered by Pastor Eddie Medel, The Miracle Center Church, guest of Councilmember Rebecca J. Viagran, District 3.
- 2. Mayor Nirenberg led the Pledge of Allegiance to the Flag of the United States of America.
- **3.** Approval of Minutes of the City Council Regular Meetings of March 20 21, 2019.

Mayor Nirenberg recognized City Attorney Segovia. Mr. Segovia announced that the approval of the minutes was a procedural item in which the City Council determined whether they accurately reflect the proceedings of March 20-21, 2019. Therefore; public comment would not be permitted.

Councilmember Treviño moved to approve the Minutes of the City Council Regular Meetings of March 20-21, 2019. Councilmember Hall seconded the motion. The motion to approve prevailed by the following vote:

AYE: 11 - Mayor Nirenberg, Treviño, Hall, Viagran, Saldaña, Gonzales, Brockhouse, Sandoval, Pelaez, Courage, and Perry

MOTION FROM THE FLOOR

Mayor Nirenberg recognized City Attorney Segovia. Mr. Segovia stated that a motion would be made by Councilmember Brockhouse as he had given notice under Robert's Rules of Order the previous week during the City Council Meeting. He noted that the item was not posted on the agenda; thus, discussion should be limited to the procedural request only. He added that staff could answer factual questions.

Councilmember Brockhouse stated that he would like to have the opportunity to debate and have a conversation about an item that was previously voted on.

Councilmember Brockhouse announced that in accordance with the notice given at the April 11, 2019 City Council Meeting; he made a motion to place on the May 2, 2019 City Council Agenda an item for the deliberation and action to rescind the amendment that removed Chick-Fil-A from operating at the San Antonio International Airport, Ordinance 2019-03-21-0221 adopted on March 21, 2019. Councilmember Perry seconded the motion.

Councilmember Gonzales expressed concern with the motion made on the floor without sufficient information.

Councilmember Pelaez asked why individuals were not being allowed to speak on said item. Mr. Segovia replied that the item was not posted on the agenda and a member of the public could not speak to the issue without discussing its merits. Councilmember Pelaez expressed concern with the item being placed on the May 2, 2019 Council Agenda two days prior to the General Election.

Councilmember Perry asked why the item would be brought back on May 2, 2019. Councilmember Brockhouse stated that said date was provided by Mr. Segovia. Mr. Segovia stated that it was based on the three-step process in which the first step provided notice; the second step was the motion being made by Councilmember Brockhouse; and the third step was placing it on the next available agenda. Councilmember Perry seconded the motion due to the many concerns he had received from his constituents.

Councilmember Sandoval stated that the issue deserved more consideration than it was given

and that she would support further discussion at a B Session.

Councilmember Hall asked if there was a legal basis regarding the previous action taken. Mr. Segovia replied that they were not revisiting the contract and did not believe there were any legal issues in terms of the previous action. Councilmember Hall stated that a decision had been made and he felt they should maintain that decision unless there was a legal issue.

Councilmember Courage expressed concern that he did not have enough information on the issue when it was previously brought before the City Council. Councilmember Courage moved to incorporate a friendly amendment to the motion by Councilmember Brockhouse that said item be added to the B Session on May 1, 2019. Councilmembers Brockhouse and Perry accepted the friendly amendment.

Councilmember Viagran stated that she would have liked to discuss the issue further at a B Session as she previously requested. She expressed concern with the disservice to the city, applicants, citizens, and community.

Mayor Nirenberg stated that regardless of the outcome; no business operating within the law has been or shall be barred from operating in the City of San Antonio.

The motion to reconsider the removal of Chick-Fil-A failed by the following vote:

Mayor Nirenberg called upon Mr. Jack M. Finger to speak.

Jack M. Finger spoke in opposition to the lease agreement with the Martinez Street Women's Center (Item 9) noting concerns with the type of programming they offer. He also expressed concern with the lawsuit settlement (Item 15).

Councilmember Hall introduced District 2 Council Candidate Salena Santibanez Quipzot. He also recognized District 2 Board Appointees Jose Picon, Katalina R. Munoz, and James E. McNamara (Items 14A, B, and C) and thanked them for their service.

The motion to approve the remaining Consent Agenda Items prevailed by the following vote:

CONSENT ITEMS CONCLUDED

INDIVIDUAL ITEM FOR STAFF BRIEFING

City Clerk Vacek read the caption for Item 4:

4. Briefing and possible action on legislation filed in the 86th Regular State Legislative Session, an update on the status of proposed State legislation and its impact on the City of San Antonio. [Carlos Contreras, Assistant City Manager; Jeff Coyle, Director, Government and Public Affairs]

Jeff Coyle provided an overview of the 86th State Legislative Session noting that 7,456 total bills and joint Resolutions had been filed. He spoke to the bills related to Employment Benefits/Paid Sick Leave, Property Taxes, Transportation Funding, and City Issues.

Mayor Nirenberg called upon the citizens registered to speak.

Jack M. Finger stated that he had visited the State Legislature and the State Affairs Committee had discussed issues resulting from deliberations on the Airport Concession Contract.

Working Texans for Paid Sick Time addressed the City Council in opposition to the bills that have been repackaged as SB 15 relating to Employment Benefits/Paid Sick Leave. Ms. Joleen Garcia noted concern that the bills limit the city's ability for protections and stated that power should be retained at the local level.

Councilmember Saldaña thanked Working Texans for Paid Sick Time and spoke of the need for the City Council to take a clear position as a full body. He referenced the Paid Sick Time Ordinance that was approved in August and noted that the City Council's position regarding same should not be neutral.

Councilmember Saldaña moved to have the City Council support the city's need to preserve local decisionmaking by directing the Government Relations Team to oppose any bills that would undo an Ordinance passed by the City Council and that further erode local control. Councilmember Treviño seconded the motion.

Councilmember Courage asked if the city could continue to have certain requirements on contracts. Edward Guzman replied that it could.

Councilmember Gonzales stated that the issue of Local Control was very serious and spoke of the importance of being sensitive to small business owners.

Councilmember Brockhouse stated that he was supportive of Local Control but asked of the litigation related to Paid Sick Leave. Mr. Segovia replied that the courts were trying to interpret a State Statute and that the city's focus was on the bills before the State Legislature.

Councilmember Pelaez stated that Paid Sick Leave was an important goal towards which everyone should work and also spoke of the importance of Local Control. He noted that he was disappointed that the issue was not addressed by the Intergovernmental Relations Council Committee (IGR).

Councilmember Perry stated that the IGR Committee agreed with the staff recommendation to remain neutral on the issue of Paid Sick Leave. He noted letters of concern received from the business community.

Councilmember Sandoval expressed support for the motion by Councilmember Saldaña. She noted that she would like to review alternatives from the Paid Sick Leave Committee but continued to support the Ordinance as approved by the City Council.

Councilmember Viagran stated that she had supported remaining neutral early on in the

process prior to the bill being broken up into four separate bills. She spoke of the importance of finding a balance between providing Paid Sick Leave to the community and requirements for small businesses.

Councilmember Treviño expressed support for Paid Sick Leave and stated that remaining neutral was not the right thing to do.

Mayor Nirenberg stated that the City of San Antonio was supportive of economic development, noting the importance of ensuring that the business community grows while workers are protected. He asked of language to protect the city's Non-Discrimination Ordinance (NDO). Mr. Coyle replied that the City's NDO would fall under the Local Decision-Making Priority and that staff had registered opposition to bills that directly attack the NDO. Mayor Nirenberg stated that he did not support taking a position on the bill and would like to remain neutral.

21. City Manager's Report

City Manager Walsh reported that May was Preservation Month and the Office of Historic Preservation had been working with the City Council Offices to showcase legacy businesses in each of the Council Districts. He noted that the photos would be released during May as a way to celebrate legacy businesses and promote the program. He mentioned that an official kickoff party for Preservation Month would take place on Thursday, May 2nd at the Historic Kress Building on Houston Street. He reported that the Amazing Preservation Race would be held on Saturday, May 4th and the Amazing Preservation Race for Kids was scheduled for Saturday, May 18th. He noted that individuals could participate in hands-on events like Rehab-A-Rama and the Do It Yourself and Donuts Workshop Series and provided a calendar of events.

City Manager Walsh recognized Thea Setterbo of the Office of Government and Public Affairs who had accepted a position with the Hemisfair Park Redevelopment Corporation. Mr. Walsh and the City Council thanked Ms. Setterbo for her service to the City of San Antonio. Ms. Setterbo stated that she was thankful for the recognition and honored to have served the City of San Antonio.

Mayor Nirenberg recognized Councilmember John Courage who would be celebrating his birthday on April 21st. The City Council sang Happy Birthday to Councilmember Courage.

Rebecca Cedillo representing the University Health System Hilliard Clinic spoke in support of Item Z-6.

Keith Pike stated that he was the owner of the property in Item Z-6 and thanked the Government Hill Alliance for their support.

Mike Cameron stated that he was speaking on behalf of the Devil's River Distillery in support of Item Z-6.
