

AN ORDINANCE

SCHEDULING SPECIAL CITY COUNCIL MEETINGS AS NECESSARY; AND RESCHEDULING ALL JULY 2019 AND THE FIRST AUGUST 2019 CITY COUNCIL-RELATED MEETINGS.

WHEREAS, due to the need for City staff and the City Council to meet to set goals and plan the FY 2020 budget, it is necessary to schedule special City Council meetings, and to reschedule all July and the first August 2019 City Council and Council Committee meetings; **NOW THEREFORE**:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:
