PUBLIC ENGAGEMENT OPPORTUNITIES

Dockless vehicle companies began deploying their products in San Antonio in summer 2018. On October 11, 2018, San Antonio City Council approved a six-month dockless vehicle pilot program to provide the City with an opportunity to work with the providers on solutions, to better understand this new mode of transportation, and create a safe environment for users, pedestrians and neighborhoods. The public was encouraged to submit feedback regarding dockless vehicles in a number of ways before and after the adoption of the dockless vehicle pilot program.

Dockless Vehicle Telephone Town Hall April 16, 2019







SAN ANTON



Residents were invited to register for a city-wide telephone town hall meeting on e-scooters and e-bikes on Tuesday, April 16, 2019 at 7 p.m. The telephone format allowed residents to participate wherever they were, rather than taking time out of their hectic schedules to attend a meeting in-person. The call was available in English and Spanish.

During the telephone town hall, residents asked City officials questions about e-scooters and e-bikes and shared their feedback on the City's dockless vehicle pilot program. Lori Houston, Assistant City Manager; John Jacks, CCDO Director; Art Reinhardt, TCI Interim Deputy Director; and Captain Chris Benavides, SAPD, participated in the call.

25,000 landlines across all City Council Districts were called. City Council Districts with lower participation rates in the 2019 SASpeakUp Dockless Vehicle Resident Survey were targeted with additional calls (Districts 2, 3, 4, 5, and 6). Residents could also sign up online before the call to participate.

746 residents participated in the Dockless Vehicle Telephone Town Hall Meeting.

Call participants were able to leave comments and questions after the Telephone Town Hall through a voicemail.

- 1. "If governors are possible, they should be put on. If you can control with GPS, it should be done. I see them riding on the River Walk. They need to be in safe locations. Where can they be ridden safely? Some locations aren't safe (Fredericksburg Rd. for example). I'm concerned about accidents. My daughter broke her arm on a scooter. What happens when an elderly person gets hit and breaks their hip? Who is liable? I think instructions should be left on the scooters. I had no idea you had to be 16 to ride the scooters. These scooters have been placed downtown without rules and regulations that people can easily find. I feel like San Antonio threw a bunch of scooters on the ground with no expectations from the riders or companies."
- 2. "I am very frustrated with these scooters. I live downtown, and I do not feel safe when I'm walking. I do not feel like enforcement would even be possible. I've reported over 100 incidents since mid-January to 311. Riders are drinking and riding, riders are weaving in and out, passing red lights, parking on the handicapped ramp, parking in the driveway and yard. It just doesn't seem possible to me; even with my efforts on the 100 reports, only a handful were taken care of. It's very disappointing. I feel like these scooters are worse than graffiti. Made our city look terrible and unsafe. Now people aren't walking. Healthier to walk. We have overweight people riding scooters, not walking. We have a lot of crime now, and I would prefer them monitoring the neighborhoods than monitoring scooters. We've spent a lot of time and effort on this and I don't see the benefit of it. I'm very disappointed and frustrated."
- 3. "Wanted to ask if the City officials on the call had used scooters and did they enjoy it?"

- 5. "On the River Walk there is a sign that says motorized vehicles are prohibited, but I see people riding motorized bikes on the River Walk. Are e-bikes considered motorized vehicles?"
- 6. "What are my choices if my family gets injured on a scooter? Are there legal agencies to protect me?"
- 7. "Is there a proper courtesy in the way of the flow of traffic on the sidewalks for scooters and pedestrians? Seems like scooters might be in harm's way on the street. Who has the right-of-way?"
- 8. "It was interesting to hear about the data request because when you hear about specific high-usage areas you can use dedicated or protected lanes for bikes and scooters so that cars might be able to be taken off the road and use electric vehicles and bikes instead."
- 9. "I think that technology is growing, and this is something new. I'm disappointed in the number being thrown on the San Antonio River. I want them to reduce the scooter amount. I'm happy that something new is coming, but you should come up with rules."
- 10. "Is the vendor or City liable if someone gets hurt or killed?"
- 11. "I've seen the scooters, and it's too bad they can't stay on the sidewalk or the bike lane. Some people don't care about rules."
- 12. "I jog frequently, and I'm nearly hit every time. They are mostly tourists and young people. Will you be adding more signs on the River Walk? Please don't make them so text heavy so riders can see them more easily. I am not happy about the scooters at all. They have taken away the peace on the River Walk, and I hope something is done about it."











Call participants were able to leave comments and questions after the Telephone Town Hall through a voicemail.

- 13. "What is the liability to the City if people are injured on the scooters? I work at a downtown hospital and have seen a tremendous amount of injuries come through the ER due to scooter injuries. Is the City liable in any way if the person is seriously injured? There are way too many scooters downtown, and the sidewalks look very cluttered. It is messing up our city."
- 14. "I think they should be put on a bike rack so they don't look so messy. This will prevent them from falling over or being dropped. I've seen people who aren't even trying to make them stand correctly. I think it would be helpful if SAPD can see who last used the vehicle and didn't park it correctly and ticket them. I have had issues reporting them on the 311 app."
- 15. "I'm blind and I use a cane and I do a lot of walking. The scooters are being parked on the sidewalk, and it's creating a tripping hazard. My concern is that the sidewalks are narrow, and as a blind person, I cannot see them coming, and because they are electric, we cannot hear them. It is only a matter of time before we can't see or hear them and there will be an accident."
- 16. "Require someone to scan their driver's license to use it so we can eliminate juveniles riding on them. Will notify parents if their children are using them underage. Any ID that says you're over the age of 17 should work."
- 17. "One of the primary concerns I had was that it was fairly apparent that one of the vendors wasn't registering their vehicles. They had a large number on the street, but they weren't registering them with the City. The City should have barcodes to determine if a scooter is properly registered."

GENERAL

- "It is not fair for people that own their own scooters (electric or otherwise) to be penalized by the invasion of these companies. Now I am going to follow their rules and no longer be able to use the sidewalks. Not fair."
- "I love the scooters being made available throughout downtown. The city needs to support them. As a downtown resident and someone who works downtown they are a huge benefit. It also has started attracting friends and family to come downtown more often because they don't want to walk everywhere in the heat. The one major issue I see is there are very few streets around downtown where it feels safe to ride so that's why many people will ride on sidewalks."
- "Love Lime, it eases downtown traffic, makes it easy to commute from one side to another of downtown without using my vehicle."
- "For our city to remain on the "list" of cool places to live and entertain, I feel scooters and any other means of transportation rather than a vehicle would be a wonderful addition to our city to add value and appeal both to our residents and tourists. If we can come to an agreement that's fit for all parties we should certainly collaborate."
- "So glad dockless vehicles are here! They sure made life easier in Seattle."
- •"LOVE THEM!"
- "Maintaining our downtown tech community that is growing rapidly is vital. Regulations must be a vetting process for all industries set on supplying our population with convenient transportation. Examples like Uber and Lyft are prime examples of why regulation design and process."
- "The scooters need to look fabulous and be maintained with proof of it and for filing with the city subject to random inspection."
- "I love the idea of the scooters! What I don't love is that Bird placed them with a 24-hour notice while others companies were waiting and working with the cities transportation team to create protocol and implementation strategies. I want to know how Bird plans on paying taxes and fees for operating their business on public property. I want to know how they plan to address the scooters that are already clogging the sidewalks (I have pictures.) I want to know how Bird plans on supporting rider safety if the scooter charge dies, I've already heard that some scooter's lights stop working as the charge gets lower. So:
 - How does Bird plan on paying taxes and a fine for not working with the city before hand?
 - How does the city plan on addressing the precedent Bird sent?
 - How does Bird plan on dealing with scooter clutter? With rider safety? "
- "Organization and proper storage is needed. During the day before general pickup makes city look trashed with vehicles. Why is there no option to ride any vehicle? Why has the city already sold, and now only involving public after contracts signed to be here?"
- "Why trash up the neighborhood?"
- "If the Personal Electric Vehicle (PEV) is no bigger, no heavier, and no faster than a bicycle then there is NO reason to discriminate PEVs from bicycles from a safety standpoint. PEVs should be allowed and prohibited from the exact same areas and laws as regular bicycles."







GENERAL (CONTINUED)

- "1) I work downtown and frequent the courthouse about 3x per week for work. I do not like the dockless scooters that I've seen thrown around the area in front of our courthouse. 2) Additionally the city needs to concern itself with the safety of the pedestrians, vehicles, and riders of the scooters.
 3) Who will be responsible for the injuries sustained by the person who trips over the scooter parked on the sidewalk? The city, the person who left it there, etc. 4) There absolutely needs to be a limit to the number and helmets need to be required to be worn. 5) Age limit for users under 16 yrs."
- "Please do not allow these companies to defer all liabilities or injuries to the city. (But especially the customer/riders of the scooters.) They will attempt and state for the users that they are liable for any and all injuries you or anyone, or one, property sustains by using the scooter. They will also say that the customer/rider agrees to indemnify them. PROTECT US!! Do not allow them to do that. "
- "No hurt or killed 18 year olds by the scooters. Please we are a safe town. No scooters."

• "1. As a condition of using the scooter as part of the payment of usage, there should be instantaneously a purchase for liability insurance. Should be compulsory or included. 2. Should have designated spots maybe designated by a big happy face where scooter MUST be parked."

- "1. As I see it, the problem here is that the barrier to entry for the dockless vehicle driver group has suddenly been lowered. Previously only those willing to personally invest in such vehicles could participate. That personal investment meant that riders tended to take precautions to avoid damaging equipment. Such precautions also tended to avoid inappropriate riding behavior and parting behavior. 2. Many will be one for reason or other unable to patronize the vehicles; those people should not have to suffer undue strain as a result of ridership increases. We should welcome regulation so long as it is not unduly heavy-handed and is living regulation that adapts as needed. Riders do not need to be on the sidewalk, so that increases safety and reduces pedestrian incidents. However riders should be able to follow traffic laws if on the road, we should ABSOLUTELY tend towards rules, which provide significant benefits to pedestrians without undue cost or penalty to riders. No other rules should be adopted."
- "• I think there needs to be more differentiation in the regulatory framework between e-scooters, I-Bikes, and non-motorized vehicles. Ex: non-motorized dockless should be allowed on trails, but not motorized.
- I would like to see some information about geo-fencing the vehicles.
- Currently residents are in charge of charging and relocating scooters and the providers' operations staff. Residents are not trained/familiar with the highest use locations and may not most conveniently redistribute the vehicles. Swell Cycle already has operations staff; how could they be involved?" Need many more bike lanes for scooters to ride on instead of sidewalks. Scooters are too quiet.









SAFETY

• "Helmet laws for bikes already exist, don't need new laws. Riders should be 15+ Should be treated the same as bicycles."

- "Need breathalyzers on them."
- "Big safety concern of parent and child on one vehicle and no helmet. They should follow rules same as bikes especially since they go continuously faster not being human powered. Dockless system can leave dangers of cleanup, strewn across the streets and trashed or endanger ADA sites or bus stops. Big safety concern of parent and child on one vehicle and no helmet. They should follow rules same as bikes especially since they go continuously faster not being human powered"
- "Support dockless because of convenience factor that increases use. Worried about safety factor of electric scooters for those who are not experiencedsaw tourists flying by on sidewalk with no regard for safety. Needs to be addressed."
- "Riding and docking instructions should be on every vehicle."
- •"I noticed the helmets for the Lime and Bird vehicles today. Why aren't those provided all the time?"
- "Sidewalks are for walkers and special needs. They block the sidewalks and make them unsafe. If a blind person is walking down the street, scooters in the walkway make the walkway unsafe."









AREAS OF USE

- "Where to ride- the dockless applications direct riders not to ride on sidewalks unless local law requires or permits. Where do riders go to learn what local law "requires or permits?" And how are non-locals informed of local laws while in use."
- "Dockless vehicles should not be allowed on SA River Trails, due to safety concerns."
- "Not being on sidewalks. Nobody is responsible if they have an accident. Who is responsible if they have a service dog?"
- "I believe the Mission Reach and Museum Reach sections of the Riverwalk should be accessible to electric scooters. It will encourage awareness and usage of the underutilized areas of the Riverwalk. We must be a city of innovation."
- "Scooters shouldn't be allowed at the Mission and Museum Reaches. Safety could/Would be compromised. The trails are too narrow and/or too congested. They go too fast to be safe."
- "Not allowed on sidewalks less that 1 ft. wide, nor at bus stops or school zones. Should have designated spots like Rent-a-Cars."
- "Only be used on streets with same safety factors of bicycles. Designated zones and same consequences if not safe in hospitals zones, or schools, offices."
- "Dockless vehicles should NOT be allowed on Mission and Museum Reach trails. Thank you."
- "Building bike lanes on select east-west downtown streets would solve 90% of the issues with cycling, scooters, Segways, and pedestrians."
- " Age 15 as per permits for cars. Horseshoe is too busy for additional traffic. Riding scooters on all other sections is okay! It makes the Riverwalk and Alamo Plaza far more accessible!"
- "You should be able to use the scooters anywhere you can ride a bicycle. They are very fun and safe to use."
- "I believe the horseshoe should remain closed but as for the rest they should open it for the rest: Mission Reach, Riverwalk, Museum Reach, Alamo Plaza, Trails and Paths. Theses areas are highly underutilized. If the bikes like Swell Cycle are allowed than electric scooters/electric bikes should be allowed as well. Electric is the present not the future"
- "Look at the boardwalk in Ocean City, MD. There are early morning hours where bikes are allowed on the boardwalk. Otherwise, it is foot traffic only for safety. The Riverwalk is similar. . . Narrow and should be foot traffic only during peak hours."









PARKING & DOCKLESS VEHICLES COMPANY RESPONSE TIME

• "Please make sure that ADA accessibility is still maintained. Use this policy and revenue to improve and maintain better transit/pedestrian/bike/scooter infrastructure. We need complete sidewalks and bike lanes."

• "Love the scooter concept- only wish that they would be left at designated spots (e.g. B Cycle docks) so that they can be more easily found. Note: I ride the B Cycles daily from home to work"

• "I don't think the company should be responsible for how people use or park the vehicles. That's up to individuals, and we, as a community should be policing any wonky parking. How hard is to pickup a scooter and move it 5 feet?"

• "There are not many sidewalks In San Antonio wider than 8 feet. It would be a very bad idea to regulate this rule. Scooters should be able to be marked close to the bus stop, up against the bus shelter. Dedicated vehicle docks downtown HIGHLY limits accessibility to scooters and is against the concept of dockless scooters."

• "Charging riders a fee for leaving vehicles parked inappropriately would be completely unenforceable; the logistics would be extremely difficult."

• "There should be a docking place for these vehicles. I have noticed that the scooters are left any where without consideration of safety for other pedestrians, they do not follow and rules that should be enforced."

• "On narrow sidewalks... Park them parallel instead of perpendicular. Park them out of the way. There is always an alternative solution."

• "Regarding dockless scooters in streets: Are these legal (TX law) to be used in streets? If not how can we address their reckless use by individuals without licenses, training, or oversight? Regarding parking of dockless scooters: These cannot be parked anywhere a user pleases. They are intrusive to sidewalk use and an obstacle to walkers, disabled, elderly, and handicapped. We must regulate where these are placed when not in use. "

• "Wheelchair ramps are frequently blocked by bicycles locked on them at businesses that do not (and some that do) have bicycle racks. How to get businesses that benefit so much from people arriving by both bicycles and by wheelchairs, to accommodate and welcome both? It is the bicyclist's responsibility not to block wheelchair ramp, but business created site problem by not providing bicycle racks."
