ACCEPTING A TASK ORDER TO A JOB ORDER CONTRACT WITH CON-COR, INC. FOR REPLACEMENT OF EXPANSION JOINTS OF THE LONG TERM PARKING GARAGE AT THE SAN ANTONIO INTERNATIONAL AIRPORT IN THE AMOUNT NOT TO EXCEED \$183,332.96 FROM INTERIM FINANCING IN THE LONG TERM PARKING GARAGE STRUCTURAL REPAIRS PROJECT.

WHEREAS, Ordinance No. 2018-10-11-0809 authorized a Job Order Contract with Con-Cor, Inc. to provide construction, renovation, and maintenance services to the facilities in the airport system and it is necessary to replace the expansion joints in the Long Term Parking Garage at the San Antonio International Airport; and

WHEREAS, this Ordinance approves a Task Order in the amount not to exceed of \$183,332.96 for this work; **NOW THEREFORE**,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. City staff is authorized to approve a Task Order not to exceed \$183,332.96 to the Job Order Contract with Con-Cor, Inc. for replacement of the expansion joints of the Long Term Parking Garage at the San Antonio International Airport.

SECTION 2. Payment not to exceed \$183,332.96 in SAP Fund 51099000, Airport Capital Projects, SAP Project Definition 33-00239, Parking, Long Term Parking Garage Structure, is authorized to be encumbered and made payable to Con-Cor, Inc., for the work listed in Section 1 above.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
