LEROY CAVAZOS-REYNA (COMMUNITY), MARCO BARROS (TRAVEL & TOURISM); REAPPOINTING DIANE D. RATH (AACOG), AURELINA PRADO (AVIATION INDUSTRY), FRANCISCO CRUZ (BUSINESS COMMUNITY) AND MARSHA B. HENDLER (BUSINESS COMMUNITY) FOR THE REMAINDER OF UNEXPIRED TERMS OF OFFICE TO EXPIRE MARCH 18, 2021; APPOINTING JOHN GRISELL (GROUND TRANSPORTATION INDUSTRY) AND VALERIE PEAK (TRAVEL & TOURISM) FOR THE REMAINDER OF UNEXPIRED TERMS OF OFFICE TO EXPIRE MARCH 18, 2020 TO THE AIRPORT ADVISORY COMMISSION; AND WAIVING THE TERM LIMIT REQUIREMENT FOR MARCO BARROS, DIANE D. RATH, AND MARSHA B. HENDLER FOR THIS APPOINTMENT.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:



SECTION 3. The term limit requirement for Marco Barros, Diane D. Rath and Marsha B. Hendler is waived.


SECTION 4. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.


