SECTION 2. All July 2019 and the first August 2019 City Council Meetings are rescheduled to the next available date in August 2019 as follows:



SECTION 3. All Council Committee meetings for July 2019 are suspended, to resume upon Council Committee Assignments by the Mayor.



SECTION 5. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise it is effective on the tenth day after passage.


