ORDINANCE

APPROVING A PERSONNEL COMPLEMENT OF TWO FULL-TIME POSITIONS FOR THE SAN ANTONIO METROPOLITAN HEALTH DISTRICT'S ORAL HEALTH PROGRAM FUNDED BY THE CITY'S HEAD START PROGRAM FOR EXPANDED ORAL HEALTH CASE MANAGEMENT SERVICES FOR THE PERIOD FEBRUARY 1, 2019 THROUGH JANUARY 31, 2020.

WHEREAS, the Head Start grant program is a federally-funded program administered by Health and Human Services (HHS); and

WHEREAS, the program provides early childhood education, family support and comprehensive support services to eligible children between the ages of three to five years, and their families; and

WHEREAS, the Head Start Grant serves children at or below the federal poverty line and prioritizes the most vulnerable children, including those with disabilities, experiencing homelessness and children in the foster care system; and

WHEREAS, the City's Head Start Program, administered by the Department of Human Services, also contracts with the San Antonio Metropolitan Health District (Metro Health) for dental services to include case management for children identified with an oral health concern; and

WHEREAS, over 700 children are identified each year with an untreated oral health need; and

WHEREAS, dental case management increases the ability of access to oral healthcare services for families and children of low income; and

WHEREAS, the Department of Human Services requested Metro Health's Oral Health Program increase their case management services due to their success in reaching and resolving families with children of dental needs; and

WHEREAS, Metro Health is requesting to create two Health Program Specialist I positions which will allow for expanded oral health case management services; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or designee or the Director of the San Antonio Metropolitan Health District or designee is authorized to add a personnel complement of two full-time positions for the San Antonio Metropolitan Health District's Oral Health Program funded by the City's Head

Start Program for expanded oral health case management services for the period February 1, 2019 through January 31, 2020.

SECTION 2. [FINANCIAL LANGUAGE PENDING]

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
