

## ORDINANCE

**AUTHORIZING A SECOND AMENDMENT TO THE PROFESSIONAL SERVICES AGREEMENT WITH WSP TO PERFORM AN UPDATE TO THE NOISE EXPOSURE MAPS IN SUPPORT OF THE FEDERAL AVIATION REGULATION PART 150 NOISE COMPATIBILITY PLAN IN THE AMOUNT OF \$829,831.89.**

**WHEREAS**, the Federal Aviation Administration requires airports to maintain a current Airport Master Plan, which serves as a blueprint for future development over the next twenty years; and

**WHEREAS**, the FAA also requires the airport to produce current Noise Exposure Maps in support of the airport's FAR Part 150 Noise Compatibility Plan; and

**WHEREAS**, In March 2018, City Council authorized Ordinances No. 2018-03-29-0210 and 2018-03-29-0211 for a professional services agreement for the airport development and strategic planning services with WSP and the submittal of a FAA AIP grant for Phase 1 of the Airport Strategic Development Plan in the amount of \$3,604,712.79; and

**WHEREAS**, Amendment 1 to this agreement increased the not to exceed total contract value to \$8,677,551.22

**WHEREAS**, it is now necessary to further increase the contact capacity by \$829,831.89 for the performance of required updates to the airport's Noise Exposure Maps in support of the FAR Part 150 Noise Compatibility Plan; **NOW THEREFORE**,

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City Manager or designee is authorized to execute a second amendment to the Professional Services Agreement with WSP USA, Inc., attached as **Exhibit 1**, to increase the contract capacity by \$829,831.89 for a not to exceed total contract value of \$9,507,382.90.

**SECTION 2.** *Fiscal language will be added upon receipt*

**SECTION 3.** This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
