**ORDINANCE**

**APPROVING THE FOLLOWING CONTRACTS ESTABLISHING UNIT PRICES FOR GOODS AND SERVICES FOR AN ESTIMATED ANNUAL COST OF \$671,000.00, AVAILABLE AND INCLUDED IN THE RESPECTIVE DEPARTMENTS' FY 2019 ADOPTED BUDGET: (A) GRAYBAR ELECTRIC COMPANY, INC., FOR ELECTRICAL SUPPLIES, WIRE AND CABLE; (B) CDSI, INC. DBA CHAMPION DIVERSIFIED SERVICES FOR WINDOW WASHING SERVICES FOR THE ALAMODOME; AND (C) TEX DOOR, LTD. FOR PREVENTIVE MAINTENANCE AND REPAIR SERVICES FOR AUTOMATIC GATE SYSTEMS.**

**WHEREAS**, the City is able to obtain significant savings by purchasing various materials and services on an annual contract basis; and

**WHEREAS**, this ordinance approves the following contracts: (A) Graybar Electric Company, Inc. for electrical supplies, wire and cable; (B) CDSI, Inc. DBA Champion Diversified Services for window washing services for the Alamodome; and (C) TexDoor, Ltd. for preventive maintenance and repair services for automatic gates systems; and

**WHEREAS**, this ordinance approves three low bid contracts; and

**WHEREAS**, all expenditures will be in accordance with the applicable fiscal year's budget approved by City Council; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The following bids to furnish the City with goods and services on an annual basis as shown on the attached bid tabulation sheets are hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements: (A) Graybar Electric Company, Inc. for electrical supplies, wire and cable; (B) CDSI, Inc. DBA Champion Diversified Services for window washing services for the Alamodome; and (C) TexDoor, Ltd. for preventive maintenance and repair services for automatic gates systems. The bid tabulation sheets are attached hereto and incorporated herein for all purposes as **Exhibit I**. Copies of the bids are available for inspection in the offices of the Purchasing Division of the Finance Department.

**SECTION 2.** Funds will be encumbered upon issuance of purchase orders, and payment is authorized to the vendors identified herein. All expenditures will be in accordance with the Fiscal Year 2019 budget, and such other appropriations necessary to fund the contracts through their terms as evidenced by subsequent ordinances.

**SECTION 3.** This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage.
