ORDINANCE

APPROVING A CONTRACT WITH FRED CLARK ELECTRICAL CONTRACTOR FOR A TERMINAL-A RAMP LIGHTING UPGRADE AT THE SAN ANTONIO INTERNATIONAL AIRPORT FOR A TOTAL COST OF \$109,692.00. FUNDING IS AVAILABLE FROM THE FY 2019 AIRPORT OPERATING AND MAINTENANCE FUND.

WHEREAS, bids were submitted to the City of San Antonio to provide a Terminal-A ramp lighting upgrade at the San Antonio International Airport; and

WHEREAS, Fred Clark Electrical Contractor submitted the lowest bid for a total cost of \$109,692.00; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The bid submitted by Fred Clark Electrical Contractor for a Terminal-A ramp lighting upgrade at the San Antonio International Airport for a total cost of \$109,692.00 is hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. Attached hereto and incorporated herein for all purposes as **Exhibit I** is the bid tabulation sheet. Copies of the bids are available for inspection in the offices of the Purchasing Division of the Finance Department.

SECTION 2. Funding for this ordinance in an amount of \$109,692.00 is available in Fund 51001000, Cost Center 3305030006 and General Ledger 5204050 as part of the Fiscal Year 2019 budget.

SECTION 3. Payment not to exceed the budgeted amount is authorized to Fred Clark Electrical Contractor to provide the Aviation Department with a Terminal-A ramp lighting upgrade at the San Antonio International Airport, and should be encumbered with a purchase order.

SECTION 4. The financial allocations in this ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this ordinance.

SECTION 5. This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage.
