ORDINANCE

APPROVING A FUNDING AGREEMENT WITH ROADRUNNER ATHLETIC FOUNDATION IN AN AMOUNT NOT TO EXCEED \$10,000,000.00 FOR IMPROVEMENTS TO UTSA ATHLETICS COMPLEX, A 2017-2022 BOND FUNDED PROJECT.

WHEREAS, On May 6, 2017, San Antonio residents voted and approved the 2017-2022 General Obligation Bond Program totaling \$850 million. The Bond Program funds will be used on various capital improvement projects addressing community infrastructure needs to improve the overall quality of life in San Antonio; and

WHEREAS, As part of the program, \$10,000,000.00 in Parks, Recreation and Open Space Improvements General Obligation Bond Funds was approved for improvements to University of Texas at San Antonio (UTSA) Athletics Complex to include but not limited to locker rooms, showers, and restrooms; and

WHEREAS, UTSA is a multicultural university institution with more than 32,000 students, and UTSA is the largest university in the San Antonio metropolitan region. UTSA is planning on constructing a \$44 million new Roadrunner Athletics Center of Excellence which will serve as a hub for the 350+ student-athletes participating in 17 NCAA Division I sport programs at UTSA; and

WHEREAS, the 2017-2022 Bond funds will support the associated improvements for UTSA Roadrunner Athletics Center of Excellence. The City's funding will go toward the construction of UTSA Roadrunner Athletics Center of Excellence soccer and track facility and outdoor grass practice fields; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or designee or the Director of Transportation & Capital Improvements Department or designee, is authorized to finalize and execute a funding agreement with the Roadrunner Athletic Foundation in an amount not to exceed \$10,000,000.00 for improvements to University of Texas at San Antonio Athletics Complex. A copy of the funding agreement in substantially final form is attached hereto and incorporated herein for all purposes as **EXHIBIT A.**

SECTION 2. Payment is authorized to be encumbered and made payable to Roadrunner Athletic Foundation for improvements to University of Texas at San Antonio (UTSA) Athletics Complex in the amount not to exceed \$10,000,000.00 per the table below:

Payment is limited to the amounts budgeted in the Operating and/or Capital Budget funding sources identified. All expenditures will comply with approved operating and/or capital budgets for current and future fiscal years.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Fund Numbers, Project Definitions, WBS Elements, Internal Orders, Fund Centers, Cost Centers, Functional Areas, Funds Reservation Document Numbers, and GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
