

ORDINANCE 2019-06-13-0512

**APPROVING THE RENAMING OF PEREZ STREET TO ROBERT
B GREEN WAY, BETWEEN NORTH FRIO STREET AND IH-35,
LOCATED IN COUNCIL DISTRICT 5.**

* * * * *

WHEREAS, Development Services Department received a request originating from University Health System to rename Perez Street to “Robert B Green Way” between North Frio Street and IH-35 to honor the life and legacy of Robert B. Green in San Antonio, which is centered around the historic Robert B. Green Memorial Hospital; and

WHEREAS, staff began implementing this request through the street renaming process as required by Chapter 6 of the City Code; and

WHEREAS, staff conducted a technical review, finding the change to conform to City Code requirements for street renaming; and

WHEREAS, staff forwarded the request to all City of San Antonio departments and outside agencies for review and only identified concerns from the City’s Office of Historic Preservation; and

WHEREAS, the United States Postal Service approved the proposed street name change on March 5, 2019, in accordance with Chapter 35, Section 506(h)(1) of the Unified Development Code; and

WHEREAS, staff properly posted and mailed notice of this street renaming request to abutting property owners, and notice requirements for renaming of the street have been satisfied in accordance with Chapter 6 of the City Code; and

WHEREAS, the Historic Design and Review Commission held a public meeting on April 17, 2019 whereby it recommended denial due to historical significance; and

WHEREAS, a community public meeting was held on April 25, 2019 with no opposition present; and

WHEREAS, the Planning Commission held a public hearing on May 22, 2019 allowing all interested persons to be heard, and recommended approval; **NOW THEREFORE**,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:


SECTION 1. “Perez Street” located in City Council District 5 between North Frio Street and IH-35 is hereby renamed “Robert B Green Way”. All naming requirements of Chapter 6 of the City Code have been met. The location of the street name change is more specifically depicted in Attachment I. City staff is directed to provide appropriate signage to this effect.

SECTION 2. No fiscal ordinance language is required.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This Ordinance is effective immediately upon receipt of eight affirmative votes; otherwise, it is effective 10 days after passage.






