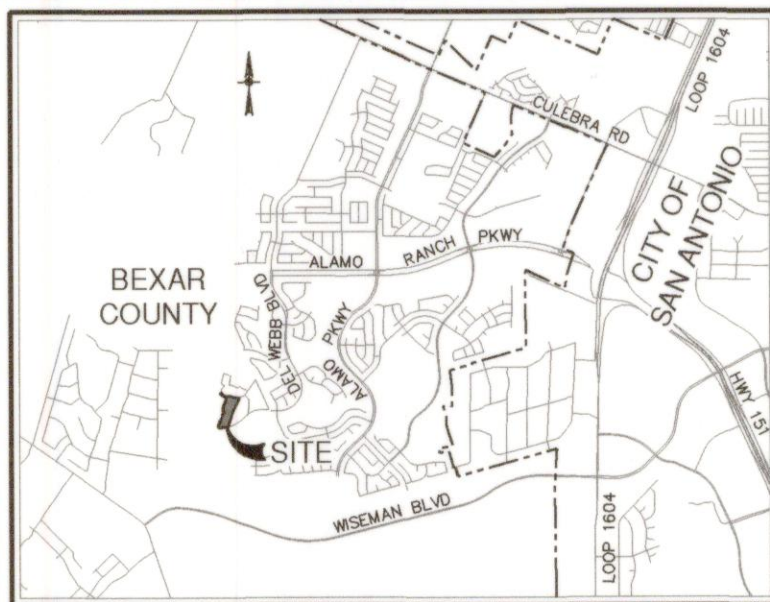

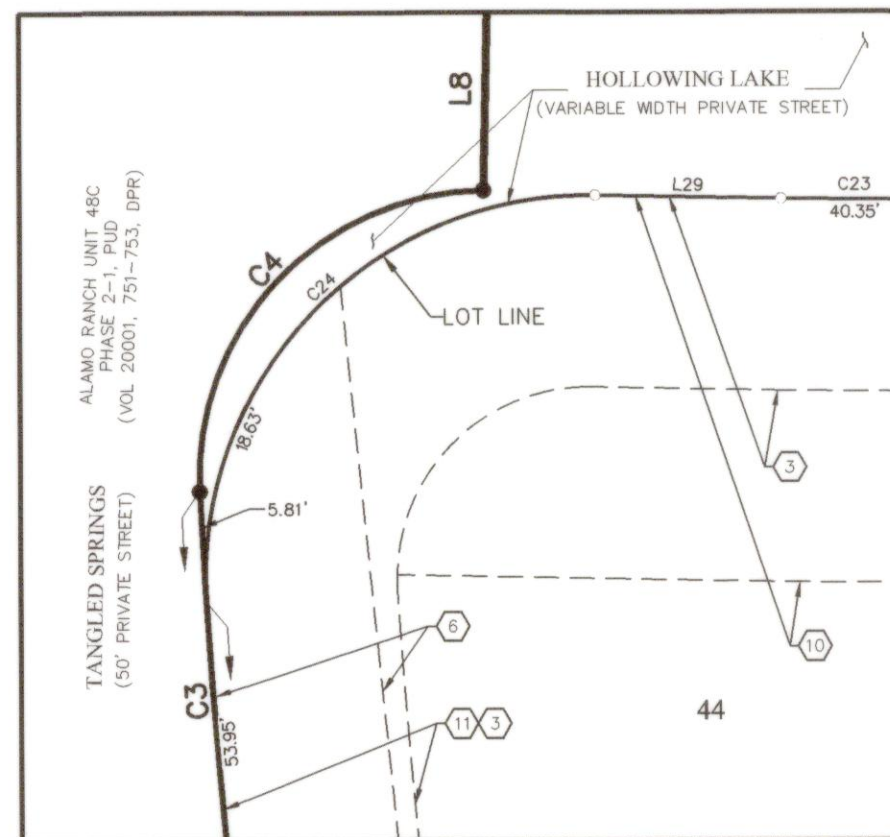

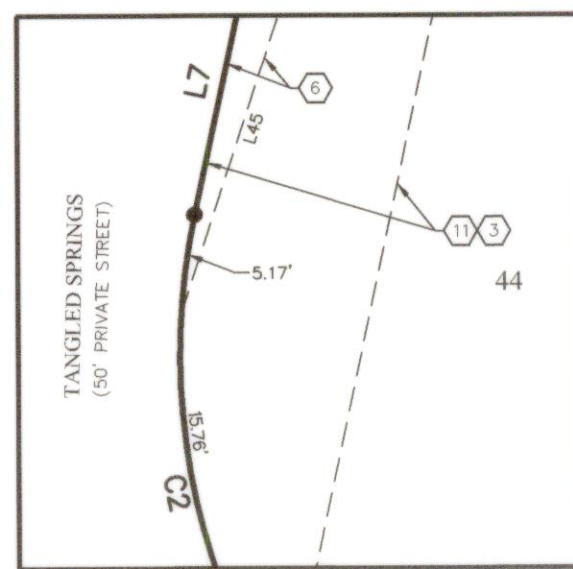
DETAIL "B"
