ORDINANCE 2019-06-20-0553

AUTHORIZING A THREE-YEAR PROFESSIONAL SERVICES CONTRACT WITH DAVID A. MARKS, M.D., P.A., IN AN ANNUAL AMOUNT OF \$36,000.00 TO PROVIDE MEDICAL OVERSIGHT TO THE SAN ANTONIO FIRE DEPARTMENT'S HEALTH AND WELLNESS PROGRAM WITH THE OPTION TO EXTEND FOR TWO ADDITIONAL ONE YEAR PERIODS IN AN ANNUAL AMOUNT OF \$38,400.00 FOR A TOTAL CONTRACT VALUE OF \$184,800.00.

WHEREAS, the San Antonio Fire Department Wellness Center utilizes a medical doctor to provide medical services and medical oversight; and

WHEREAS, the City issued a Request for Qualifications on March 22, 2019; and

WHEREAS, the evaluation committee comprised of San Antonio Fire Department representatives evaluated one responsive proposal submitted by the current San Antonio Fire Department Wellness Center physician; and

WHEREAS, as a result of the review process, staff recommends Dr. Marks, be able to continue to perform physician services and medical oversight for the San Antonio Fire Department Wellness clinic; and

WHEREAS, said Contract provides for an initial 3-year term, beginning July 17, 2019 through July 17, 2022, with two (2), one (1) year options to renew; and

WHEREAS, funding in the amount of \$36,000.00 is available in the General Fund Budget with additional funding for future fiscal years subject to the appropriation of funds; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or designee is hereby authorized to execute a professional services contract with Dr. David A. Marks for the period from July 17, 2019 to July 17, 2022, with the option for the City to extend the contract for two (2) one (1) year renewals.

SECTION 2. Funding in the amount of \$36,000.00 for this Ordinance is available in Fund 11001000, Cost Center 2015090001 and General Ledger 5201040 as part of the Fiscal Year 2019 budget.

SECTION 3. Additional funding Of \$148,000.00 is contingent upon City Council approval of subsequent budgets within the term length of this contract.

SECTION 4. Payment not to exceed the budgeted amount is authorized to David A. Marks, MD, PA to provide services as a wellness physician, providing medical oversight of the San Antonio Fire Department's Health and Wellness Program.

SECTION 5. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Cost Centers, WBS Elements, Internal Orders, General Ledger Accounts, and Fund Numbers as necessary to carry out the purpose of this Ordinance

SECTION 6. This Ordinance becomes effective immediately if passed and approved by eight (8) affirmative votes; otherwise this Ordinance shall take effect ten (10) days from the date of passage.
