**RESOLUTION NO.**

**RECOMMENDING THE EXTENSION OF THE CITY LIMITS BY THE FULL PURPOSE ANNEXATION OF APPROXIMATELY 150.26 ACRES OF LAND, LOCATED AT 4526 SOUTH LOOP 1604, NORTHEAST OF THE INTERSECTION OF SOUTH LOOP 1604 AND IH-37 SOUTH, CONTIGUOUS TO THE CITY OF SAN ANTONIO LIMITS AND LOCATED WITHIN THE SAN ANTONIO EXTRATERRITORIAL JURISDICTION (ETJ) IN BEXAR COUNTY, AS REQUESTED BY HALLIBURTON ENERGY SERVICES, INC., PURSUANT TO THE PROVISIONS OF CHAPTER 43 OF THE TEXAS LOCAL GOVERNMENT CODE.**

**WHEREAS**, Chapter 43 of the Texas Local Government Code provides that a city may conduct annexation for full purposes upon the request of the land owner; and

**WHEREAS**, the owner of the Halliburton property previously requested and was granted a release from the ten-year Industrial District Non-Annexation Agreement with the City of San Antonio, which was approved in 2016, in order to initiate the annexation process with the City of San Antonio; and

**WHEREAS**, the owner of the Halliburton property requested the annexation of approximately 150.26 acres of land, located at 4526 South Loop 1604, northeast of the intersection of South Loop 1604 and IH-37 South; and

**WHEREAS**, the proposed annexation is consistent with the City of San Antonio Annexation Policy by which San Antonio considers annexation necessary to ensure logical planning boundaries and service delivery boundaries; and

**WHEREAS**, the annexation area is contiguous to the City of San Antonio limits, within San Antonio's Extraterritorial Jurisdiction (ETJ); and

**WHEREAS**, Section 123A of the Charter of the City of San Antonio requires the Planning Commission to make a recommendation to City Council on the proposed annexation; and

**WHEREAS**, the San Antonio Planning Commission held a public hearing and considered of the full purpose annexation of 150.26 acres, located at 4526 South Loop 1604, on May 8, 2019; and

**NOW, THEREFORE, BE IT RESOLVED BY THE PLANNING COMMISSION OF THE CITY OF SAN ANTONIO:**

**SECTION 1:** The San Antonio Planning Commission recommends the **approval** of the full purpose annexation of approximately 150.26 acres, located at 4526 South Loop 1604, as requested by Halliburton Energy Services, Inc., **legally** described as CB 4136B BLK LOT 4

HALLIBURTON SAN ANTONIO SUBD and depicted in “**Attachment A,**” contiguous to the City of San Antonio and within the City of San Antonio’s ETJ in Bexar County, pursuant to the provisions of Chapter 43 of the Texas Local Government Code.


