AUTHORIZING A JOINT USE AGREEMENT WITH CELLCO PARTNERSHIP DBA VERIZON WIRELESS TO ALLOW ACCESS TO PROPERTY AT THE SAN ANTONIO INTERNATIONAL AIRPORT FOR THE INSTALLATION AND MAINTENANCE OF THE FIBER LINES, CABLES, CONDUIT AND ASSOCIATED MATERIALS NECESSARY FOR THE DISTRIBUTED ANTENNA SYSTEM AT THE SAN ANTONIO INTERNATIONAL AIRPORT AT NO COST TO THE AIRPORT.

WHEREAS, on March 7, 2019, City Council approved Ordinance No. 2019-03-07-0184 authorizing Verizon Wireless to design, install, operate and maintain a neutral-host Distributed Antenna System at the San Antonio International Airport; and

WHEREAS, a Joint Use Agreement is required to allow Verizon Wireless and its subcontractors to access the property for the purpose of installing and maintaining fiber lines, conduit and associated materials necessary for the servicing and operation of the DAS; and

WHEREAS, Verizon Wireless and their representatives shall be responsible for the procurement, installation and maintenance of the fiber lines, conduit and associated materials, and will adhere to all safety standards as well as federal, state or local regulations; and

WHEREAS, it is now necessary to authorize the attached Joint Use Agreement required for the completion of this project; NOW THEREFORE,

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The City Manager or designee is authorized to execute a Joint Use Agreement with Cellco Partnership, DBA Verizon Wireless, attached as **Exhibit 1**, for the installation and maintenance of fiber lines, conduit and associated materials to the San Antonio International Airport located at 9800 Airport Blvd.

**SECTION 2.** Verizon Wireless is solely responsible for all costs of construction, installation, repairs, maintenance, operation, and the like, for any property placed by Verizon Wireless at San Antonio International Airport. There is no cost to be borne by the Airport.

**SECTION 3.** This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
