The City Council of San Antonio convened in a Special Meeting. City Clerk Leticia Vacek took the Roll Call noting a quorum with the following Councilmembers present:

1. Ordinance canvassing the June 8, 2019 Run-Off Election for City Council Districts 2, 4, 6, and Mayor. [Leticia M. Vacek, City Clerk]

City Clerk Leticia Vacek presented the official results of the June 8, 2019 Run-Off Election for Council Districts 2, 4, 6, and Mayor. She presented the Total Votes Cast for each candidate in the Run-Off Election as follows:

#### **FOR MEMBER OF COUNCIL, PLACE NO. 2**

Keith A. Toney	3,010 votes
Jada L. Andrews-Sullivan	3,277 votes

#### **FOR MEMBER OF COUNCIL, PLACE NO. 4**

Adriana Rocha Garcia	4,262 votes
Johnny Arredondo	1,622 votes

#### **FOR MEMBER OF COUNCIL, PLACE NO. 6**

Melissa Cabello Havrda	6,648 votes
Andy Green	5,006 votes

#### **FOR MEMBER OF COUNCIL, MAYOR (PLACE NO. 11)**

Ron Nirenberg	61,741 votes
Greg Brockhouse	59,051 votes

Mrs. Vacek reported the total number of votes cast, including provisional and overseas mail ballots, was 121,033 and the total number of registered voters for the City of San Antonio was 784,148. She stated that the voter turnout for the City of San Antonio Run-Off Election was 15.43%.

Mrs. Vacek declared that as a result of the Run-Off Election, the following persons were elected for a two-year term of office commencing June 19, 2019:

Jada L. Andrews-Sullivan, Member of Council, Place No. 2  
Adriana Rocha Garcia, Member of Council, Place No. 4  
Melissa Cabello Havrda, Member of Council, Place No. 6  
Ron Nirenberg, Member of Council, Mayor (Place No. 11)

Councilmember Viagran moved to adopt the ordinance canvassing the Election Results of the June 8, 2019 Run-Off Election. Councilmember Saldaña seconded the motion. The motion prevailed by the following vote:
