Brief Description of Item(s) and Use: This contract will provide the Parks and Recreation Department with contractors to furnish and deliver a wide variety of 1, 5, 7, and 15 gallon trees on an as-needed basis throughout the City of San Antonio. The list of shade and ornamental tree species includes, but is not limited to, Anacacho Orchid, Bur Oak, Cedar Elm, Chinkapin Oak, Crape Myrtle, Desert-Willow, Eve's Necklace, Lacey Oak, Live Oak, Mexican Buckeye, Mexican Plum, Mexican Sycamore, Mexican White Oak, Montezuma Cypress, Pecan (native or papershell), Possumhaw, Retama (thornless), Texas Mountain Laurel, Texas Persimmon, Texas Red Oak, and Texas Redbud. The list of fruit species includes, but is not limited to, apple, apricot, avocado, fig, lemon, lime, nectarine, olive, orange, peach, pear, persimmon, plum, and pomegranate. The trees will be utilized by the Parks and Recreation Department to enhance the tree population throughout the City of San Antonio and for tree adoption opportunities for the public.
