## AN ORDINANCE

AMENDING THE LAND USE PLAN CONTAINED IN THE NORTH CENTRAL COMMUNITY PLAN, A COMPONENT OF THE COMPREHENSIVE MASTER PLAN OF THE CITY, BY CHANGING THE USE OF APPROXIMATELY 0.764 ACRES OF LAND LOCATED AT 1006 CHULIE STREET, 1010 CHULIE STREET AND 707 REXFORD, LEGALLY DESCRIBED LOT 19, LOT 23, AND LOT 24, BLOCK 20, NCB 13035 FROM "LOW DENSITY RESIDENTIAL" TO "MEDIUM DENSITY RESIDENTIAL"

**WHEREAS**, the North Central Community Plan was adopted on September 16, 2010 by City Council as a component of the City's Comprehensive Master Plan adopted May 29, 1997; and

**WHEREAS**, the Unified Development Code requires consistency between zoning and the Comprehensive Master Plan and Section 213.003 of the Texas Local Government Code allows amendment of the Comprehensive Master Plan following a public hearing and review by the Planning Commission; and

**WHEREAS,** a public hearing was held on July 24, 2019 by the Planning Commission allowing all interested citizens to be heard; and

WHEREAS, the San Antonio City Council has considered the effect of this amendment to the Comprehensive Master Plan of the City and has determined that it conforms to the approval criteria set forth in the Unified Development Code §35-420, Comprehensive, Neighborhood, Community, and Perimeter Plans; NOW THEREFORE;

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The North Central Community Plan, a component of the comprehensive master plan of the city, by changing the use of approximately 0.764 acres of land located at 1006 Chulie street, 1010 Chulie street and 707 Rexford, legally described Lot 19, Lot 23, and Lot 24, Block 20, NCB 13035 from "Low Density Residential" to "Medium Density Residential." All portions of land mentioned are depicted in **Attachments "I"** attached hereto and incorporated herein for all purposes.
