

ORDINANCE 2019-08-08-0586

**SETTING THE FOLLOWING DATES, TIMES, AND LOCATIONS FOR THE FIRST AND SECOND PUBLIC HEARINGS ON THE PROPOSED BUDGET FOR FY 2019-2020: WEDNESDAY, AUGUST 28, 2019, 6:00 P.M., AND WEDNESDAY, SEPTEMBER 4, 2019, 6:00 P.M., IN THE CITY COUNCIL CHAMBER, 105 MAIN PLAZA; SETTING THE FOLLOWING DATES, TIMES AND LOCATIONS FOR THE FIRST AND SECOND PUBLIC HEARINGS ON THE PROPOSED TAX RATE FOR THE TAX YEAR BEGINNING JANUARY 1, 2019 AND ENDING DECEMBER 31, 2019: WEDNESDAY, AUGUST 28, 2019, 6:00 P.M., AND WEDNESDAY, SEPTEMBER 4, 2019, 6:00 P.M., IN THE CITY COUNCIL CHAMBER, 105 MAIN PLAZA; AND SCHEDULING BUDGET WORK SESSIONS.**

**WHEREAS**, a public hearing on the proposed annual budget of the City of San Antonio is required by Section 102.006 of the Texas Local Government Code and Section 82 of the City Charter; and

**WHEREAS**, two public hearings on the proposed annual tax rate of the City of San Antonio are required by Chapter 26 of the Texas Property Tax Code if it exceeds the lower of the rollback rate or the effective rate; and

**WHEREAS**, the proposed Tax Year 2019 total tax rate of 55.827 cents per \$100.00 of taxable valuation does exceed the Tax Year 2019 effective tax rate of 54.504 cents per \$100.00 of taxable valuation, thus requiring the two tax rate public hearings described above; and

**WHEREAS**, the City Council now wishes to officially set the dates, times, and locations for the public hearings and provide for public notice; and

**WHEREAS**, there is a need to schedule additional special meetings for City Staff and City Council to plan the FY 2020 budget; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** Two (2) public hearings on the Fiscal Year 2019-2020 proposed budget are hereby scheduled for Wednesday, August 28, 2019, from 6:00 p.m. until completion, and for Wednesday, September 4, 2019, from 6:00 p.m. until completion, with both hearings to be held in the City Council Chamber, 105 Main Plaza.

**SECTION 2.** Because the proposed tax rate for the Tax Year beginning January 1, 2019 and ending December 31, 2019 heretofore set by the City Council by an Ordinance approved and adopted on the same date as this Ordinance, exceeds the lower of the rollback rate or the

effective rate, two public hearings on the proposed tax rate are required by Chapter 26 of the Texas Property Tax Code. The first public hearing on the proposed tax rate is hereby scheduled for Wednesday, August 28, 2019 from 6:00 p.m. until completion, in the City Council Chamber, 105 Main Plaza. The second public hearing on the proposed tax rate is hereby scheduled for Wednesday, September 4, 2019, from 6:00 p.m. until completion, in the City Council Chamber, 105 Main Plaza.

**SECTION 3.** City staff is hereby directed to publish, post and broadcast notice of each of these public hearings as required by applicable laws, including, but not limited to, the City Charter, Chapter 102 of the Local Government Code, as amended (budget), and Chapter 26 of the Texas Property Tax Code and Chapter 140 of the Local Government Code (tax rate).




**SECTION 5.** This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
