

ORDINANCE

2019-08-15-0632

AWARDING A CONSTRUCTION CONTRACT, TO INCLUDE AN ADDITIVE ALTERNATE, TO E-Z BEL CONSTRUCTION, LLC IN AN AMOUNT NOT TO EXCEED \$976,587.79 FOR THE APPLEWHITE ROAD INTERSECTION (SOUTH OF WATSON ROAD) PROJECT, LOCATED IN COUNCIL DISTRICT 3.

WHEREAS, in May 2017 San Antonio voters approved the 2017-2022 Bond Program which included \$1,000,000.00 for improvements associated with the Applewhite Road Intersection (South of Watson Road) Project; and

WHEREAS, this Ordinance awards a construction contract for the reconstruction and widening of the west side of Applewhite Road to accommodate dual left turn lanes from Applewhite Road southbound to the entrance south of Watson Road, redesign the traffic signalization, and, per the additive alternate, extension of the proposed improvements to accommodate a southbound right turn lane into a stub-out for a future four-legged intersection; and

WHEREAS, the City advertised for bids for the Applewhite Road Intersection Project in May 2019 and received four (4) bids which were opened in June 2019; and

WHEREAS, this Ordinance accepts the lowest responsive bid submitted by E-Z Bel Construction, LLC in an amount not to exceed \$976,587.79; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The lowest responsive bid by E-Z Bel Construction, LLC in an amount not to exceed \$976,587.79 for the Applewhite Road Intersection (South of Watson Road) Project, is hereby accepted. All other bids will be considered rejected upon execution of a contract by the successful bidder and the deposit of all required bonds and insurance.

SECTION 2. Payment is authorized to be encumbered and made payable to E-Z Bel Construction, LLC for the Applewhite Road Intersection (South of Watson Road) Project in the amount not to exceed \$976,587.79 in Fund 45099000, WBS Element 23-01559-05-02-01, and GL 5201140.

SECTION 3. Payment is limited to the amounts budgeted in the Operating and/or Capital Budget funding sources identified. All expenditures will comply with approved operating and/or capital budgets for current and future fiscal years.



specific Fund Numbers, Project Definitions, WBS Elements, Internal Orders, Fund Centers, Cost Centers, Functional Areas, Funds Reservation Document Numbers, and GL Accounts as necessary to carry out the purpose of this Ordinance.


SECTION 5. This Ordinance shall be effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
