AUTHORIZING THE CLOSURE, VACATION, AND ABANDONMENT OF 0.497 OF AN ACRE OF AN IMPROVED SECTION OF PUBLIC RIGHT OF WAY AT THE CORNER OF RIVERSIDE DRIVE AND ROOSEVELT AVENUE COMMONLY KNOWN AS H.F. MCCARTY DRIVE AS REQUESTED BY 2450 ROOSEVELT, LTD. FOR A FEE OF \$44,185.00 IN COUNCIL DISTRICT 3.

WHEREAS, 2450 Roosevelt, Ltd. ("Petitioner") has requested the closure, vacation and abandonment of 0.497 of an acre of an improved portion of public right of way located at the northeast corner of Riverside Drive and Roosevelt Avenue, commonly known as H.F. McCarty Drive, as depicted in **Attachment I**, in Council District 3; and

WHEREAS, Petitioner purchased a 5.4 acre property located at 2450 Roosevelt Avenue at the northeast corner of Roosevelt Avenue and Riverside Drive which had been vacant for over 10 years and has repurposed the property into 65 market rate apartments; and

WHEREAS, a small portion of the right-of-way between Roosevelt Avenue and the Petitioner's property was renamed H. F. McCarty Drive under Ordinance 63334, dated July 31, 1986; and

WHEREAS, the Petitioner has requested the closure, vacation, and abandonment of H. F. McCarty Drive in order to landscape the right-of-way, which will be incorporated within the footprint of the development for curb appeal for apartment occupants; and

WHEREAS, the Petitioner's request was reviewed and approved by City of San Antonio ("City") departments, utilities and the Texas Department of Transportation ("TXDoT"), as TXDoT maintains the portion of Roosevelt Avenue abutting the property. In accordance with Chapter 37 of the Municipal Code, notification signs were posted near the proposed closure and letters were sent to property owners within a 500 foot radius; and

WHEREAS, Planning Commission reviewed this request at its regular meeting on July 24, 2019; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Council hereby authorizes the closure, vacation, and abandonment of 0.497 of an acre of an improved portion of public right of way located at the northeast corner of Riverside Drive and Roosevelt Avenue, commonly known as H.F. McCarty Drive, as described depicted in **Attachment II** in Council District 3. All attachments are incorporated into this Ordinance for all purposes as if they were fully set forth. **Attachment II** controls over any discrepancy between it and **Attachment I**.

SECTION 2. Funds generated by this Ordinance will be deposited into Fund 11001000 Internal Order 223000000253 and General Ledger Account 4903101.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Cost Centers, WBS Elements, Internal Orders, General Ledger Accounts, and Fund Numbers as necessary to carry out the purpose of this Ordinance.

SECTION 4. This Ordinance becomes effective 10 days after passage, unless it receives the eight votes requisite to immediate effectiveness under San Antonio Municipal Code § 1-15, in which case it becomes effective immediately.


