AWARDING A CONSTRUCTION CONTRACT TO ALL IN CONSTRUCTION, L.L.C. IN AN AMOUNT NOT TO EXCEED \$938,848.51 FOR THE N. ELLISON DRIVE AT WISEMAN BOULEVARD INTERSECTION IMPROVEMENT PROJECT, A FY 2018 ADVANCED TRANSPORTATION DISTRICT FUNDED PROJECT, LOCATED IN COUNCIL DISTRICT 6.

WHEREAS, this Ordinance provides for the construction of a traffic signal at the N. Ellison Drive at Wiseman Boulevard intersection which is currently an all-way stop intersection; and

WHEREAS, this Ordinance awards a construction contract for the construction of a traffic signal, sidewalks and curb ramps to improve the efficiency and safety of vehicular and pedestrian traffic at the intersection; and

WHEREAS, the City advertised for bids for the N. Ellison Drive at Wiseman Boulevard Intersection Improvement Project on November 2, 2018 and opened bids on November 27, 2018; and

WHEREAS, this Ordinance accepts the lowest responsive bid submitted by All In Construction, L.L.C. in an amount not to \$938,848.51; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The lowest responsive bid by All In Construction, L.L.C. in an amount not to exceed \$938,848.51 for the N. Ellison Drive at Wiseman Boulevard Intersection Improvement Project, is hereby accepted. All other bids will be considered rejected upon execution of a contract by the successful bidder and the deposit of all required bonds and insurance.

SECTION 2. Payment is authorized to be encumbered and made payable to All In Construction, L.L.C. for the N. Ellison Drive at Wiseman Boulevard Intersection Improvement Project in the amount not to exceed \$938,848.51 per the table below:

The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Fund Numbers, Project Definitions, WBS Elements, Internal Orders, Fund Centers, Cost Centers, Functional Areas, Funds Reservation Document Numbers, and GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 5. This Ordinance shall be effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
