AN ORDINANCE

AMENDING THE LAND USE PLAN CONTAINED IN NORTH SECTOR PLAN, A COMPONENT OF THE COMPREHENSIVE MASTER PLAN OF THE CITY, BY CHANGING THE USE OF APPROXIMATELY 1.924 ACRES OF LAND LOCATED AT GENERALLY LOCATED AT THE SOUTHWEST CORNER OF OVERLOOK PARKWAY AND US HIGHWAY 281 NORTH, LEGALLY DESCRIBED AS 1.924 ACRES OUT OF CB 4865 AND CB 4926 FROM "SUBURBAN TIER" TO "GENERAL URBAN TIER".

WHEREAS, the North Sector Plan was adopted on August 5, 2010 by City Council as a component of the City's Comprehensive Master Plan adopted May 29, 1997; and

WHEREAS, the Unified Development Code requires consistency between zoning and the Comprehensive Master Plan and Section 213.003 of the TEXAS LOCAL GOVERNMENT CODE allows amendment of the Comprehensive Master Plan following a public hearing and review by the Planning Commission; and

WHEREAS, a public hearing was held on August 14, 2019 by the Planning Commission allowing all interested citizens to be heard; and

WHEREAS, the San Antonio City Council has considered the effect of this amendment to the Comprehensive Master Plan of the City and has determined that it conforms to the approval criteria set forth in the Unified Development Code §35-420, Comprehensive, Neighborhood, Community, and Perimeter Plans; NOW THEREFORE;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The North Sector Plan, a component of the Comprehensive Master Plan of the City, is hereby amended by changing the use of approximately 1.924 acres of land located at Generally located at the Southwest corner of Overlook Parkway and US Highway 281 North, legally described as 1.924 acres out of CB 4865 and CB 4926, from "Suburban Tier" to "General Urban Tier". All portions of land mentioned are depicted in **Attachments "I"** attached hereto and incorporated herein for all purposes.

SECTION 2. This ordinance shall take effect {Effective Date}.
