

Please provide a brief narrative outlining your reasons for seeking appointment to this board or commission:	Since starting to work with the San Antonio rescue community 6 years ago, I have become very aware of the numerous challenges that the city faces, even as San Antonio Animal Care Services (ACS) has, working with hundreds of rescues and individuals, achieved the "No Kill" designation (90 percent or better Live Release Rate). Since being given the honor of representing District 1 on the ACSAB, I have worked with ACS and other ACSAB members to make measurable improvements in reducing roadside puppy sales increasing spay and neuter opportunities and enhancing domestic pet care while increasing public safety. There is still a lot to do for District 1 and the city to improve our results and also our reputation, and over the past year I have strengthened relationships and insights to allow us to get more support for our district. I am very committed to continue to work with ACS staff and leadership, other ACS Advisory Board members, and rescues and individuals on these areas. I am especially excited about serving the citizens of District 1, to address their unique concerns and challenges.
