

Being 0.192 acres of land, more or less, out of Lot 9, New City Block 3598, Borcher Subdivision, in the City of San Antonio, Bexar County, Texas, according to the map thereof recorded in Volume 105, Page 169, Deed and Plat Records, Bexar County, Texas, SAVE AND EXCEPT that 0.006 acre tract conveyed to the State of Texas recorded in Volume 4719, Page 515, Official Public Records, Bexar County, Texas, said 0.192 acres being that same property conveyed in a Warranty Deed with Vendor's Lien recorded in Volture 11102, Page 1489, Official Public Records, Bexar County, Texas, said 0.192 acres being more particularly described by metes and bounds as follows:

COMMENCING at a $1 / 2$ inch iron rod found (monument of record dignity) for the southwest comer of the Miguel Angel Rocha Soria Tract (Volume 8203, Page 667), same being the southeast corner of the San Antonio Positive Solutions, inc 1.60 acres (Volume 15917, Page 791), and on the North Right-of-Way line of W. Poplar Street, same also being the POLNT OF COMMENCEMENT;

THENCE along the North Right-of-Way line of said W. Poplar Street, North 70 degrees 33 minutes 34 seconds West, a distance of 156.51 feet (called 156 feet) to a point for the southwest corner of Lot 7 of said Borcher Subdivision and the southeast corner of the Raul Zandejas, et ux Tract (Volume 1414, Page 832);

THENCE along the line common to said Lot 7 and said Zandejas Tract, North 19 degrees 26 minutes 26 seconds East, a distance of 88.07 feet (called 88.00 feet) to a point from which a metal post bears, North 49 degrees 59 minutes 46 seconds West, 0.54 feet, said point being the southeast corner of this 0.192 acres, same being the southeast corner of said Lot 9 and the northeast corner of said Zandejas Tract and the POINT OF BEGINNING;

THENCE along the line common to this 0.192 acres and said Zandejas Tract, North 68 degrees 35 minutes 13 seconds West (called North 68 degrees 49 minutes 07 seconds West), a distance of I59.81 feet to a point from which a metal post bears, North 35 degrees 38 minutes 44 seconds West, 1.27 feet. said point being the southwest corner of this 0.192 acres, same being the northwest corner of the Adelfa B. Zavala Tract (Volume 8024, Page 1970) and on the East Rightof Way line of Camaron Street;

THENCE along the East Right-of-Way line of said Camaron Street, the following courses and distances:

North 31 degrees 10 minutes 23 seconds West (called North 31 degrees 23 minutes 37 seconds West), a distance of 38.67 feet to a point for an angle corner;

North 01 degrees 28 minutes 10 seconds East (called North 01 degrees 14 minutes 56 se East), a distance of 25.00 feet to a metal post found for the northwest corner of this 0.192 acres, same being the northwest corner of said Lot 9 and the southwest corner of L.ot 8 of said Borcher Subdivision;

THENCE along the line common to this 0.192 acres and said I. ots 8 and 9 , South 67 degrees 43 minutes 29 seconds East (called South 67 degrees 56 minutes 43 seconds East), a distance of 198.00 feet to a metal post found for the northeast corner of this 0.192 acres, same being the northeast corner of said Lot 9 and the southeast corner of said Lot 8 , same also being on the West boundary of said Lot 7;

THENCE along the line common to this 0.192 acres and said Lot 7, South 20 degrees 00 minutes 37 seconds West (called South 19 degrees 47 minutes 23 seconds West), a distance of 44.03 feet (called 44.00 feet) to the POINT OF BEGINNING;

THENCR along the line common to this 0.210 acres and said Zendejas Tract, South 19 degiees 13 minutes 12 se West, 96.60 foet to a polnt from which a 1 inch iron pipe found bears, North 11 degrecs 32 minutes 05 seconds Erst, 3.72 fect, a $1 / 2$ inch iron rod found (monument of record dignity) found for the southeast comer of Lot 5 of said Borcher's Subdivision bears, South 70 degrees 46 minutes 48 seconds East, 210.00 fect, said point being the southeast corner of this 0.210 acres, same belng the southwest comer of ssid Zendejas Tract and at the intersection of the Noth Right-of-Way line of W. Poplar Street aod the notheast Right-of-Way line of Camaron St ;

THENCE along the northeast Righe-of-Way line of said Camaron SL North 31 degrecs 59 minutes 10 secends Wiest (called North 31 degrees 23 minutes 37 seconds Wiest), a distance of 149.63 feet (called 147.30 feet) to the I'OINT OI BEGINNING, and contalning 0.210 acres of land, more or less.
