Description of Event/Purpose (Describe in 200-300 words):

San Antonio Sports Fit Family Challenge is a free, annual, 4-month, county-wide family fitness program that began in 2010. The program is implemented over the summer months of May through August. The goal of Fit Family Challenge is to improve the health and wellness of San Antonio families through routine family-friendly physical activity and nutrition education. Our target audience is San Antonio families with children under 18 years of age, focusing on families living in the 10 zip codes originally identified by San Antonio Metro Health as at risk of poor health. Families are asked to exercise the recommended 60 minutes a day, set health and fitness foals, track physical and nutrition activity, make a commitment to eat healthier, and attend Fit Family Challenge events. The program includes a comprehensive evaluation using surveys, observations, and BMI analysis of target families to measure program impact on family health and wellness.

San Antonio Sports, a 501c3, is requesting a City Council Project Funds (CCPF) grant from City Council District 4 to support the implementation of the county-wide family-friendly fitness and nutrition event, District 4 Heroes 5K and 10K, that will take place at Port San Antonio on May 11, 2019. This event is part of the Fit Family Challenge summer events schedule. The event meets the goal of CCPF as it promotes family health and wellness through the promotion of community recreation. The event will allow families to participate in a free 5K and 10K on the south side of San Antonio. The event also includes a health fair, health screenings, health incentives, and recognition for leading an active and healthy lifestyle. Approximately 4500-5000 family members will participate in the event. Funds will support program costs that were needed to implement the D4 Heroes 5K & 10K event (see related expenses section).

For over 30 years, San Antonio Sports has put our city on the global stage. From NCAA Championships to the Rock 'n' Roll San Antonio Marathon, the premier events San Antonio Sports has hosted have delivered more than \$600 million for our local economy.

But San Antonio Sports is not just about big events. San Antonio Sports is a nonprofit organization that works to transform our community through the power of sport. San Antonio Sports recognizes the link between healthy bodies and healthy minds and works every day to provide sports and fitness programs that inspire children and their families to live active, healthy lives.

San Antonio Sports is in 308 local elementary and middle schools with our Kids Rock Marathon training program and Go!Kids Challenge™. Kids Rock is a non-timed, non-competitive event for children in grades K-7 that takes place in December during marathon weekend. Kids can become marathon finishers on race day by completing a cumulative marathon training program in the weeks leading up to the race. Or, they can simply choose to run the 1-mile course on race day.

Go!Kids Challenge is a free program that encourages kids to be active and make water their primary drink of choice. This program takes place in the spring semester and is offered to children in grades K-5. Schools who register for the program receive activity logs for their students to track their daily physical activity.

San Antonio Sports *i play! afterschool* program ignites a love of sport in third through fifth graders, while teaching them life lessons about active living, good nutrition and strong personal character. During the 2018-2019 school year, *i play! afterschool* served 1,200 children in 48 elementary schools in San Antonio and Harlandale school districts. Students in *i play! afterschool* participate in five, 5-week sports development sessions (track, soccer, volleyball, tennis, and basketball). Each sport unit culminates in a fun tournament where the kids can demonstrate their new skills and parents, family, and friends can cheer them on.

The San Antonio Sports Fit Family Challenge expands the kids' fitness efforts to the entire family through a free, 12-week summer family fitness program that encourages families to be active together and live a healthier lifestyle. 2019 marks the tenth year for Fit Family Challenge. San Antonio Sports partners with six schools districts (San Antonio, Harlandale, Northside, Southwest, South San Antonio, and Southside) as well as Baptist Temple Church and Antioch Sports Complex to host free weekly fitness classes. Along with the eight free fitness classes held weekly, there is a big community event held every six weeks. At each big event participants who have attended the weekly workouts are entered to win a \$1,000 cash prize.

D4 Heroes 5K & 10K

District 4 - Fit Family Challenge Big Event

San Antonio Sports is requesting City Council Project Funds (CCPF) from City Council District 4 to support the county-wide family-friendly 5K event, *District 4 Heroes 5K & 10K*, which took place at Port San Antonio on Mary 11, 2019. The *D4 Heroes 5K and 10K* is part of the Fit Family Challenge, a free 12-week summer program. This year was the 9th year of the *D4 Heroes 5K* and the second year for the 10K race.

This free event gave families the opportunity to participate in a free 5K and 10K run. The event also included a health fair, healthy incentives, and recognition for leading an active and healthy lifestyle. 4,400 individuals registered for the event. A number of firemen, police officers, and service men and women participated in the event. The youngest participant was not yet a year old and the oldest participant was 88 years old. The first 3,000 participants to cross the finish line received a D4 Heroes 5K/10K medal.

Funds will support program costs that were needed to implement the D4 Heroes 5K & 10K event.

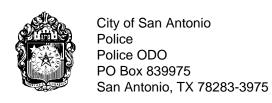

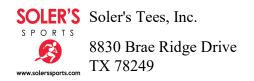
