

AN ORDINANCE 2019-10-31-0882

APPROVING THE ACCEPTANCE OF GRANT FUNDS IN AN AMOUNT UP TO \$500,000.00 FROM THE U.S. DEPARTMENT OF JUSTICE, OFFICE OF JUSTICE PROGRAMS, BUREAU OF JUSTICE STATISTICS FOR THE TRANSITION TO THE FEDERAL BUREAU OF INVESTIGATION'S NATIONAL INCIDENT-BASED REPORTING SYSTEM.

WHEREAS, the U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Statistics (BJS) awarded a grant to the San Antonio Police Department (SAPD) for the 2019 National Crime Statistics Exchange Implementation Assistance Program Continued Support for Program Participant grant for the period of October 1, 2016 through September 30, 2021, in the amount of \$500,000.00; and

WHEREAS, the grant application, which was authorized under a Special Category Grant Opportunity Submission Authorization Request, was submitted to the BJS on July 30, 2019; and

WHEREAS, the grant will be used to assist in funding the transition of the SAPD standard reporting method of the Uniform Crime Reporting Program to the Federal Bureau of Investigation's (FBI) National Incident-Based Reporting System (NIBRS); and

WHEREAS, this grant supplements a grant of the same name in the amount of \$87,978.00; and

WHEREAS, this grant does not require an in-kind or cash match; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager and designee, and the San Antonio Chief of Police and designee, are hereby authorized to accept supplemental grant funds in the amount up to \$500,000.00 from the U.S. Department of Justice, Office of Justice Programs, BJS for the transition to the FBI's NIBRS as the standard reporting method of the Uniform Crime Reporting Program for the grant period October 1, 2016 to September 30, 2021.


SECTION 2. Fund 2202817000 entitled "SAPD Conversion to NIBRS" and IO 117000000222 are hereby designated for the use in the accounting for the fiscal transaction in the acceptance of these supplemental funds. Upon acceptance, the sum of up to \$500,000.00 will be appropriated in said fund and IO. The proposed budget is attached hereto and incorporated herein for all purposes as **Exhibit A**. A formal budget will be provided upon acceptance of funds.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal

Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
