

ORDINANCE 2019-11-07-0903

**AWARDING A CONSTRUCTION CONTRACT TO J&P PAVING COMPANY, INC. IN AN AMOUNT NOT TO EXCEED \$9,588,863.50 FOR 2020 STREET REHABILITATION PACKAGE 3, OF WHICH FUNDS IN THE AMOUNT NOT TO EXCEED \$218,020.00 WILL BE REIMBURSED BY SAN ANTONIO WATER SYSTEM (SAWS) AND \$28,000.00 WILL BE REIMBURSED BY CPS ENERGY FOR NECESSARY ADJUSTMENTS TO EXISTING INFRASTRUCTURE.**

**WHEREAS**, with the adoption of the FY 2020 Budget on September 12, 2019, City Council approved \$110 million for the FY 2020 Street Maintenance Program; and

**WHEREAS**, the City advertised the 2020 Street Rehabilitation Package 3 in September 2019 and received four bids which were opened on October 8, 2019; and

**WHEREAS**, this Ordinance accepts the lowest responsive bid submitted by J&P Paving Company, Inc. in an amount not to exceed \$9,588,863.50; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The lowest responsive bid submitted by J&P Paving Company, Inc. in an amount not to exceed \$9,588,863.50 for 2020 Street Rehabilitation Package 3, is hereby accepted. All other bids will be considered rejected upon execution of a contract by the successful bidder and the deposit of all required bonds and insurance certificates.

**SECTION 2.** Payment is authorized to be encumbered and made payable to J&P Paving Co. in an amount not to exceed \$9,588,863.50. Payment is in support of the 2020 Street Rehabilitation Package 3, using Fund 440099000 and the WBS elements and GL accounts in the table below. Funding is provided by GO Bonds, Tax Notes, General Fund and ATD, and is budgeted as part of the FY2020-FY2025 Capital Improvements Program, with reimbursement of \$218,020.00 from SAWS and \$28,000.00 from CPS.




**SECTION 3.** The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Fund Numbers, Project Definitions, WBS Elements, Internal Orders, Fund Centers, Cost Centers, Functional Areas, Funds Reservation Document Numbers, and GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 4.** This Ordinance shall be effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
