FISHER (DISTRICT 1) AND CYRA M. TREVINO (DISTRICT 7) AS ALTERNATES TO THE ZONING BOARD OF ADJUSTMENT FOR THE REMAINDER OF UNEXPIRED TERMS OF OFFICE TO EXPIRE MAY 31, 2021, AS THE BOARD COMPOSITION HAS INCREASED FROM SIX ALTERNATE MEMBERS TO SEVEN.



SECTION 1. Anne Englert (District 1), Frank A. Quijano (District 1), Seymour Battle III (District 2), Kevin W. Love (District 9), Jonathan Delmer (District 10), are appointed, and Arlene B. Fisher (District 1) and Cyra M. Trevino (District 7) are re-appointed, as Alternates to the Zoning Board of Adjustment for the remainder of unexpired terms of office to expire May 31, 2021.

SECTION 2. This Ordinance is effective immediately upon the receipt of eight affirmative votes, or in the event eight affirmative votes are not received, on the tenth day after passage.


