Whereas, the City of San Antonio ("City") and the Everbridge, Inc. ("Vendor") entered into an agreement for subscriptions for emergency notification for the Aviation Department pursuant to Ordinance No. 2016-09-08-0676; and

Whereas, the Texas Local Government Code section 271.103 provides that a local government may purchase goods or services available under Federal supply schedules of the United States General Services Administration ("GSA") and such purchase satisfies any state law requiring competitive bidding; and

Whereas, the parties agree to amend the contract term thereby increasing the estimated contract value of \$148,000 by \$67,000 to an estimated total contract value of \$215,000; and

Whereas, this amendment is authorized pursuant to the section entitled "Amendments" in 006, General Terms & Conditions of the above referenced contract; and

Now Therefore, the City of San Antonio and the vendor identified above hereby agree to amend the contract as follows:

1. AMENDMENTS

A. In Section 004 – Specifications/Scope of Services, the third paragraph is revised to read as follows:

GSA Contract #GS-35F-0692P expires July 18, 2024. The terms, conditions, and pricing of the GSA contract shall apply to this Amendment 2.

B. Section 005-Supplemental Terms & Conditions, Original Contract Term, is hereby amended to read:

This contract shall begin upon the effective date of the ordinance awarding the contract, or SEPTEMBER 14, 2016, whichever is later. This contract shall begin upon the date specified in the award letter, if it does not exceed \$50,000. This contract shall terminate on JULY 18, 2024.

C. Section 005-Supplemental Terms & Conditions, Renewals, is hereby deleted entirety.

2. PROVISIONS REMAIN IN EFFECT

All other terms, conditions, covenants and provisions of the above referenced contract, as previously amended, not specifically mentioned herein and revised by this document, are retained in their entirety, unchanged, and remain in full force in effect for the duration of said contract, and any renewals thereof.

3. ENTIRE AGREEMENT

This contract, as amended, embodies the complete agreement of the parties hereto with regard to the subject matter contained herein, superseding all oral or written previous and contemporary agreements between the parties relating to matters herein.
