ORDINANCE

AWARDING A TASK ORDER CONTRACT TO J&P PAVING CO., INC. IN AN AMOUNT NOT TO EXCEED \$15,847,765.20 FOR 2020 STREET REHABILITATION PACKAGE 4, OF WHICH FUNDS IN THE AMOUNT NOT TO EXCEED \$326,040.00 WILL BE REIMBURSED BY SAN ANTONIO WATER SYSTEM (SAWS) AND THE AMOUNT NOT TO EXCEED \$42,000.00 WILL BE REIMBURSED BY CPS ENERGY FOR NECESSARY ADJUSTMENTS TO THEIR EXISTING INFRASTRUCTURE.

WHEREAS, with the adoption of the FY 2020 Budget on September 12, 2019, City Council approved \$110 million for the FY 2020 Street Maintenance Program, which is comprised of both in-house and contract street maintenance projects; and

WHEREAS, the City advertised the 2020 Street Rehabilitation Package 4 in September 2019 and received five bids which were opened on October 22, 2019; and

WHEREAS, this Ordinance accepts the lowest responsive bid submitted by J&P Paving Co., Inc. in an amount not to exceed \$15,847,765.20; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The lowest responsive bid submitted by J&P Paving Co., Inc. in an amount not to exceed \$15,847,765.20 for the 2020 Street Rehabilitation Package 4, is hereby accepted. All other bids will be considered rejected upon execution of a contract by the successful bidder and the deposit of all required bonds and insurance certificates.

SECTION 2. A work order contract not to exceed \$15,847,765.20 is authorized with J&P Paving Co., Inc. Reimbursement of \$326,040.00 will be provided by SAWS and reimbursement of \$42,000.00 provided by CPS..

SECTION 3. Funding for this Ordinance will be identified when work orders are issued. If funding for any work order is not previously appropriated, funding will be identified and appropriated through subsequent City Council action. Payment is limited to the amounts budgeted in the Operating, Grants, and/or Capital Budget funding sources identified. All expenditures will comply with Operating, Grants, and/or Capital Budgets for current and future fiscal years.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject
