**SECTION 1.** The City Council hereby directs City Staff to initiate a plan amendment and a change in zoning on 8.523 acres out of NCB 17338, located at 17115 Redland Road, to appropriate land use designations and zoning districts consistent with land development in the Redland Road Corridor, to take appropriate steps to bring forward to the Planning Commission and Zoning Commission for recommendations and to City Council for final action.

**SECTION 2.** All fees associated with the plan amendment and zoning will be absorbed by the Development Services Department.

**SECTION 3.** This resolution shall be effective immediately upon passage by eight or more affirmative votes; otherwise, it shall be effective on the tenth day after passage.
