

ORDINANCE

APPROVING A CONSTRUCTION CONTRACT WITH D. WILSON CONSTRUCTION IN AN AMOUNT NOT TO EXCEED \$1,291,310.81 FOR THE AIRPORT OPERATIONS AREA PERIMETER FENCE PROJECT AT THE SAN ANTONIO INTERNATIONAL AIRPORT WITH FUNDING BUDGETED AND AVAILABLE FROM INTERIM AIRPORT FINANCING.

WHEREAS, the City released an Invitation for Bids in September 2019 for the Airport Operations Area Perimeter Fence project at the San Antonio International Airport and received eight bids in response; and

WHEREAS, this Ordinance accepts the lowest responsive bid submitted by D. Wilson Construction in the amount not to exceed \$1,291,310.81 for completion of this project; **NOW THEREFORE**,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The lowest responsive bid by D. Wilson Construction. in the amount not to exceed \$1,291,310.81 for the Airport Operations Area Perimeter Fence project at the San Antonio International Airport is accepted. All other bids are rejected upon execution of a contract by D. Wilson Construction and the deposit of all required bonds and insurance certificates, or the expiration of 90 days from the effective date of this Ordinance, whichever occurs first. The contract is authorized for execution within 90 days and is attached in substantially final format as **Attachment 1**.

SECTION 2. *fiscal details to be added upon receipt.*

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
