# ORDINANCE 2020-01-30-0066

## APPROVING AN INCREASE TO THE SBA TOWER LEASE AGREEMENTS FOR THE SAN ANTONIO PUBLIC SAFETY RADIO SYSTEM.

\* \* \* \* \*

WHEREAS, the City of San Antonio manages SBA tower lease agreements in support of the Alamo Area Regional Radio System ("AARRS") used by City of San Antonio ("City") Police and Fire Departments, CPS Energy, Bexar County ("County") and surrounding participating agencies; and

WHEREAS, On February 15, 2018, Council approved a contract for the construction, system delivery, and system operation of a new P25 compliant public safety radio system, referred to as the Alamo Area Regional Radio System ("AARRS"). On the same date, Council also authorized the execution of an Interlocal Agreement (ILA) between the City, Bexar County (County), and CPS Energy (CPS) for County and CPS to make financial contributions to obtain minority ownership interests in the AARRS; and

**WHEREAS**, On June 13, 2019 Council approved Ordinance 2019-06-13-0518 that authorized lease agreements in support of the new P25 radio system which included the SBA lease for San Geronimo Tower Site. The lease agreement also supports this location during a transition period starting April 1, 2019 then ending January 31, 2022; and

WHEREAS, the increase to the lease rate of \$7,208.97 is due to the increase in microwave dish size from 4 feet to 6 feet. The increase cost for this adjustment will be shared by the entities based on the Interlocal Agreement approved by the City, CPS Energy and Bexar County; NOW THEREFORE:

### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The City Manager or designee, or the Director of the ITSD Department or designee, is authorized to execute an amendment to the SBA lease for San Geronimo Tower Site in support of the AARRS. A copy of the amended agreement, in final form, is attached hereto and incorporated herein for all purposes as **Attachment I**.

**SECTION 2.** Payment is authorized to be encumbered and made payable to SBA Towers IV, LLC in an amount not to exceed \$7,208.96. Payment is in support of the Radio and Radio System Replacement Adds Project, using Fund 43099000, and the WBS Elements and GL Accounts in the table below. Funding is provided by COs, and is in the FY2020-FY2025 CIP Budget.

**SECTION 3.** The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Fund Numbers, Project Definitions, WBS Elements, Internal Orders, Fund Centers, Cost Centers, Functional Areas, Funds Reservation Document Numbers, and GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 4.** This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.



### AMENDMENT TO ANTENNA SITE RENTAL AGREEMENT

THIS AMENDMENT TO ANTENNA SITE RENTAL AGREEMENT (hereinafter "Amendment") is made as of the \_\_\_\_\_ day of \_\_\_\_\_\_, 2019, by and between SBA TOWERS IV, LLC, a Delaware limited liability company (hereinafter "Landlord"), and CITY OF SAN ANTONIO, a Texas municipality (hereinafter "Tenant").

WHEREAS, San Geronimo Tower Company, Inc., a Texas corporation and Tenant entered into an Antenna Site Rental Agreement dated January 9, 2003, as amended on December 12, 2007 and on June 17, 2019 (collectively, the "Agreement") pursuant to which Tenant leases a portion of the tower site located at 18970 State Hwy 16, Helotes, Texas 78023; and

WHEREAS, San Geronimo Tower Company, Inc. and Optasite Towers, LLC, a Delaware limited liability company entered into an Instrument of Assignment and Consent on July 3, 2008; and

WHEREAS, Optasite Towers, LLC amended and changed its name to SBA Infrastructure, LLC on September 18, 2008; and

WHEREAS, SBA Infrastructure, LLC and SBA Towers IV, LLC, a Florida limited liability company entered into a Master Assignment and Assumption Agreement dated August 9, 2012; and

WHEREAS, SBA Towers IV, LLC converted into Landlord effective February 28, 2013; and

WHEREAS, Landlord and Tenant desire and intend to amend and supplement the Agreement as provided herein.

**NOW, THEREFORE,** for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto covenant, agree and bind themselves to the following modifications to the Agreement:

1. The **Equipment** section of the Agreement are hereby amended in accordance with Item 3 below.

2. The **Rental Payment** section of the Agreement is hereby amended to increase Tenant's rental payments as follows:

The current monthly rental payment shall be increased by Three Hundred Dollars and Zero Cents (\$300.00) effective the date this Amendment is last executed by both parties, partial month to be prorated. Rental payment, including any and all rental payment increases, will be escalated in accordance with the Agreement.

3. **Exhibit B** – Antenna and Equipment List attached to the Agreement is hereby deleted in its entirety and replaced with the revised Exhibit B – Antenna and Equipment List attached hereto and made a part of the Agreement.

4. Capitalized terms not defined in this Amendment will have the meaning ascribed to such terms in the Agreement.

5. This Amendment will be governed by and construed and enforced in accordance with the laws of the state in which the Premises are located without regard to principles of conflicts of law.

6. Except as specifically set forth in this Amendment, the Agreement is otherwise unmodified and remains in full force and effect and is hereby ratified and reaffirmed. In the event of any inconsistencies between the Agreement and this Amendment, the terms of this Amendment shall take precedence.

7. This Amendment shall be effective as of the date last executed by both parties.
