




#### Phase 1: 20-Year Passenger Forecast







# Airfield Alternatives Development & Evaluation Process

Development of alternative airfield options placing runways in multiple locations to suit 20 and 50 year needs for the airport.

Room

Review of comparative costs, major environmental concerns, ease of implementation, and operational flexibility. Review of long-term flexibility, ease of phasing, comparative cost, and financial feasibility.

Final review of airfield alternatives modification, aviation safety, noise contour analysis, and drainage analysis. Evaluation of terminal including passenger convenience and experience, constructability, interface with aircraft, connections with ground access.

Preferred airfield alternatives (two or three) will be matched with the final terminal alternatives.

Round 04

Develop overall composite alternatives for all airport functional areas, combining the preferred airfield and terminal alternatives with the preferred access and support alternatives.

- Alternatives were eliminated or moved to the next level based on "Flaws" or "Merits" of the alternative.





#### Noise Exposure Map Update Following SDP

- 1. The update to the Noise Exposure Map (NEM) will:
  - Depict new and forecast noise contours
  - Collect and show data on the map regarding current and future associated land use compatibility
  - Include 8 public open house-style workshops for stakeholders
- 2. SDP Alternatives Evaluation will consider potential noise exposure
- 3. Noise exposure and mitigation measures will be addressed before a project can be implemented
