## ORDINANCE 2020-02-13-0088

APPROVING A FIVE-YEAR CONCESSION AGREEMENT WITH R&J INTERNATIONAL COMPANY, DBA DUNKIN DONUTS, TO OPERATE A FOOD SERVICE KIOSK CONCESSION AT THE EXIT OF THE SKYBRIDGE INTO TERMINAL B OF THE SAN ANTONIO INTERNATIONAL AIRPORT WITH THE OPTION TO EXTEND FOR THREE ONE-YEAR PERIODS, AT AN ANNUAL RENTAL RATE OF AT LEAST 10% OF GROSS REVENUE SALES.

WHEREAS, R&J International Company, dba Dunkin Donuts formerly operated a food service kiosk in Terminal A of the San Antonio International Airport until the space they occupied was demolished for the construction of an additional security lane at the Security Checkpoint; and

**WHEREAS**, passengers have expressed interest in food and beverage options in pre-security areas of Terminal B; and

WHEREAS, the City and R&J International Company, dba Dunkin Donuts have agreed to enter into a concession agreement for a food and beverage service kiosk in the pre-security area of Terminal B of San Antonio International Airport, for an initial term of five years, with three additional one-year options at an annual rental rate of at least 10% of the facility's gross revenue sales; **NOW THEREFORE:** 

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The City Manager or designee is authorized to execute the Concession Agreement with R&J International Company, dba Dunkin Donuts, a copy of which is set out in **Exhibit 1.** 

**SECTION 2.** Funds generated by this ordinance will be deposited in Fund 51001000, Internal Order 233000000166, and General Ledger Account 4009022.

**SECTION 3.** This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
