

COUNCIL CONSIDERATION REQUEST

- Submitted by Councilman Manny Pelaez (CD 8) in April 2019
 - Discussion & review of requirements for baby changing stations
 - Installed in all restroom facilities in new buildings
 - Installed in restroom facilities of existing building permits needed when remodeling or altering



Issue Proposed for Consideration

I ask for your support for the inclusion of the following item on the agenda of the earliest available meeting of the Governance Committee:

Discussion and review of requirements that baby changing stations be installed in all new buildings with restroom facilities that offer public accommodations, and all existing buildings when restroom facilities are added or altered in a manner that requires a building permit.

Brief Background

Often, baby changing stations are only available in women's public restrooms or not at all. The requirement of baby changing stations to be made available in both men's and women's bathroom in all new buildings will allow parents to have equal access to sanitary and safe spaces when changing their baby's diapers. Requiring diaper changing tables in public restrooms will help mothers and fathers ensure the health and safety of their children. Many parents or caregivers are forced to change their baby's diapers in public, to use unsanitary and unsafe bathroom sinks or floors, or to even delay changing a diaper altogether.


PROCESS

TIMELINE



PROPOSED LANGUAGE

- Other cities or states with similar language:
 - Dallas
 - New Mexico
 - New York
- Definition of baby changing station:
 - a baby changing station, deck, table, or similar
 - intended for changing diapers on children weighing up to 50 lbs.



PROPOSED LANGUAGE

- Minimum one baby changing station accessible to all genders in buildings that are:
 - Assembly (restaurants, theaters, amusement buildings, etc.)
 - Mercantile (stores, malls, etc.)
 - Hospitals
 - City owned buildings
 - Providing services to citizens
 - Have public restrooms
- New buildings
- When restrooms in existing buildings are:
 - Newly built
 - Expanded by more than 50 sq. ft.

- Language in Ch. 10
- Cost = \$450 to \$1,000 per unit (installed)

RECOMMENDATION



- Staff recommends approval of proposed language for baby changing stations requirements
- Review possibility of adult changing stations in new city facilities
