AMENDING THE MAJOR THOROUGHFARE PLAN, A COMPONENT OF THE CITY OF SAN ANTONIO MASTER PLAN, BY REALIGNING A PROPOSED SEGMENT OF TALLEY ROAD, A SECONDARY ARTERIAL TYPE A REQUIRING 86 FEET OF RIGHT-OF-WAY, FROM OLD TALLEY ROAD TO APPROXIMATELY 1,500 FEET SOUTH OF CARTWRIGHT TRAIL GENERALLY LOCATED IN WESTERN BEXAR COUNTY.

WHEREAS, the City of San Antonio Major Thoroughfare Plan was adopted on September 21, 1978 by City Council as a component of the City of San Antonio Master Plan; and

WHEREAS, a public hearing was held on January 22, 2020 by the Planning Commission allowing all interested citizens to be heard: NOW THEREFORE;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1: The Major Thoroughfare Plan, a component of the Master Plan of the City, is amended to realign a proposed segment of Talley Road, a Secondary Arterial Type A requiring 86 feet of Right-of-Way, from Old Talley Road to approximately 1,500 feet south of Cartwright Trail. The Amendment is more particularly described in **ATTACHMENT "A,"** attached hereto and incorporated herein for all purposes.

SECTION 2: This ordinance shall become effective March 1, 2020.


