## ROLL CALL

The City Council convened in a Regular Meeting. City Clerk Leticia M. Vacek took the Roll Call noting a quorum with the following Councilmembers present:

Mayor Nirenberg asked all to observe a moment of silence for SFC Javier Gutierrez and SFC Antonio Rodriguez who were killed on February 8, 2020 in combat.

- 1. The invocation was delivered by Reverend Dr. L.J. Gillespie, Sr. with the Greater Love Missionary Baptist Church, guest of Councilmember Jada Andrews-Sullivan.

Councilmember Andrews-Sullivan moved to approve the minutes of the City Council Regular Meetings of December 12, 2019 and January 15, 2020. Councilmember Treviño seconded the motion. The motion prevailed by the following vote:

Councilmember Viagran acknowledged the passing of Ida Ramos, Senior Center Liaison for Council District 3.

## CONSENT AGENDA ITEMS

Item 4 was pulled for individual consideration and Item 24 was pulled for recusal. Mayor Nirenberg announced that Items 21C, 27I, 27L, 27M, and 27O were removed from the agenda and would not be considered.

Jack M. Finger spoke in opposition to Item 20 which called for the acceptance of funds for immediate shelter services for 18-24 year olds. He spoke in opposition to Item 27, approving Resolutions related to multifamily rental housing.

Michael Ash thanked the City Council for its consideration of his application seeking Competitive 9% Housing Tax Credits from the Texas Department of Housing and Community Affairs (TDHCA).

Councilmember Viagran highlighted Item 20 and noted that representatives across the City were present at a community input session in Council District 3 on homelessness. She noted that addressing homelessness was a priority of the City.

Councilmember Perry highlighted a 2017-2022 Bond Project in Council District 10 which was on Thousand Oaks between Wetmore and Perrin Beitel.

Councilmember Rocha Garcia moved to approve the remaining Consent Agenda Items. Councilmember Andrews-Sullivan seconded the motion. The motion prevailed by the following vote:

Mayor Nirenberg recognized Marta Peláez of the Family Violence Prevention Services for her efforts.

Councilmember Viagran thanked Marta Peláez for her work.

Councilmember Sandoval thanked Marta Peláez for her efforts.

Councilmember Peláez recused himself from voting on Item 24 by exiting the Council Chambers and noting that he had submitted the recusal forms to the City Clerk.

Councilmember Sandoval moved to approve Item 24. Councilmember Andrews-Sullivan seconded the motion to approve. The motion prevailed by the following vote:

**4.** Ordinance ordering a Sales and Use Tax Election to be held on the 2nd day of May, 2020, to authorize the continuation of the current 1/8th cent sales and use tax for

eight additional years for the benefit of the San Antonio Early Childhood Education Municipal Development Corporation's Pre-K 4 SA Program; authorizing a contract with Bexar County to conduct this election in an amount up to \$900,000.00; and appropriating funding from the Pre-K fund balance pending approval of the San Antonio Early Childhood Education Municipal Development Corporation's Board of Directors. [Carlos Contreras, Assistant City Manager; Sarah Baray, Ph.D., CEO, Pre-K 4 SA]

Elaine Mendoza introduced the members of the San Antonio Early Childhood Education Municipal Development Corporation Board who were in attendance.

Dr. Sarah Baray stated that in 2012, San Antonio voted to dedicate 1/8-cent sales tax to Pre-K 4 SA and the eight year authorization would end in 2021. She noted that Pre-K 4 SA was authorized under the Better Jobs Act which authorized City Council to initiate certain types of workforce development programs, including early childhood education, and to create a corporation to develop and implement the program. She stated that the City Council approved the bylaws, appointed board members, and approved the corporation budget. She noted that the Better Jobs Act allowed for a sales tax levy that was: 1) Directed for use of the corporation; 2) Not less than 1/8 of one percent; and 3) Approved by a simple majority of voters.

Dr. Baray stated that the mission of Pre-K 4 SA was to, in one generation, develop a world-class workforce through high-quality early childhood education. She noted that the program design included education centers, professional learning, competitive grants, and family engagement. She stated that by the end of the eight year authorization, Pre-K 4 SA will have benefited over 450,000 children. She noted that a third-party evaluation was performed to assess the value of the program and year over year; children enter Pre-K 4 SA below the national normal and leave the program above the national normal. She stated that the program had empowered families to support early learning and students had better third grade math scores, better third grade reading scores, and better attendance. She noted that for the next eight year authorization, the Pre-K 4 SA program proposed to:

- Continue to serve San Antonio's children and families with the greatest educational need at four education centers
- Create 3,000+ additional free seats for children from middle-class families
- Award grants to support quality early learning infrastructure across the City
- Offer free professional learning to strengthen San Antonio's early learning teaching corps
- Support and strengthen families as advocates
- Increase access to higher education and the workforce

Dr. Baray stated that 40% of San Antonio's four year-olds did not qualify for free public Pre-K and many of those families could not afford it in the private sector. She noted that Pre-K 4 SA would serve these families and those who qualify for Pre-K 4 SA. She stated that the Board requested the City Council's consideration to put Pre-K 4 SA before the voters for reauthorization.

Leticia Vacek stated that the Ordinance would call a Special Election for Saturday, May 2, 2020 from 7:00 am -7:00 pm. She noted that voters would vote on the adoption of a sales and use tax at the rate of 1/8 of

1% to finance the authorized programs of the San Antonio Early Childhood Education Municipal Development Corporation for the maximum period of eight years. She stated that the Ordinance would:

- Establish early voting sites
- Establish election day voting sites
- Provide for required public notice
- Authorize the City to enter into an agreement with the Bexar County Elections Office to conduct the election

Mrs. Vacek noted that Bexar County would finalize early voting and election day voting sites at a later date. She reported that the election was estimated to cost the City approximately \$900,000. She reviewed the draft list of early voting sites proposed and the election calendar. She stated that the Ordinance was coordinated with the City Attorney's Office and the Bexar County Elections Office.

Jack M. Finger stated that \$11,470 was spent for every Pre-K 4 SA student. He noted that he would like to see the second and fourth grade math and reading scores and an evaluation of the program by a neutral non-profit organization.

Stephanie Adams spoke of her daughter and the progress she has made while enrolled in Pre-K 4 SA.

Monica Sparks stated that Pre-K 4 SA benefited not just the students, but families as well.

Brandon Logan stated that since 2012, San Antonio has led the nation in comprehensive and sustainable investment in high-quality learning. He noted that Pre-K 4 SA has proven that high-quality Pre-K was scalable and provided results.

Mayor Nirenberg recessed the meeting at 9:58 am.

Mayor Nirenberg reconvened the meeting at 10:49 am.

Councilmember Rocha Garcia asked who was eligible to participate in professional learning provided by Pre-K 4 SA, how often it was offered, and the cost to school districts. Dr. Baray replied that the professional learning was provided at no cost to any early learning educator in San Antonio that worked with young children aged birth to eight years. She noted that classes were held on Saturdays and in-classroom coaching for teachers and certification programs were provided. She stated that over 21,000 individuals had participated in professional learning over the eight-year period.

Councilmember Courage stated that Pre-K 4 SA would increase the educational achievement level in San Antonio and attract companies to same. He noted that Pre-K 4 SA assisted public school systems through training programs and collaborative efforts to help schools start similar programs within their school districts.

Councilmember Viagran asked if individuals could vote at any election site and not only in their precinct. Mrs. Vacek replied that they could vote at any election site on May 2, 2020 and during early voting. Councilmember Viagran called for the development of an exit strategy following the reauthorization of Pre-K 4 SA.

Councilmember Gonzales asked why the sliding scale model for tuition would not be utilized for families making between \$45,000 and \$65,000. Dr. Baray replied that there were some families which could not afford tuition on a sliding scale. Councilmember Gonzales requested that the Board reconsider utilizing the sliding scale model for tuition for this group and focusing efforts on three-year-olds.

Councilmember Cabello Havrda asked for the number of students from Council District 6 that participated in Pre-K 4 SA and the number of those which were eligible for public Pre-K. Dr. Baray replied that 213 students from Council District 6 were enrolled in Pre-K 4 SA during the 2019-2020 school year with a total of 1,546 enrolled for the eight-year period.

Councilmember Perry asked if the cost of the proposed election was included in the Budget. Erik Walsh replied that as part of the Ordinance, funds would be allocated from the Pre-K 4 SA Fund to pay for the election. Councilmember Perry expressed concern that the election would be funded by the Pre-K 4 SA Fund. He expressed support for holding the election in November 2020 as opposed holding the election in May 2020.

Councilmember Treviño expressed his support for Pre-K 4 SA.

Councilmember Andrews-Sullivan stated that Pre-K 4 SA was a tool to end generational poverty. She pledged her support for the program and stated that she would communicate the benefits of the program to constituents.

Councilmember Peláez asked if services provided to adults to reduce homelessness, substance abuse, crime, low health outcomes, and domestic violence would cost more than the investment in early childhood education. Dr. Baray replied that it would and noted that economists have said that early education was the best investment a community could make to reduce the costs mentioned.

Councilmember Sandoval asked how the City would ensure that citizens were aware of the election. Ms. Mendoza replied that with the assistance of community partners which were proponents of the program, the City would provide the results generated by the program.

Councilmember Perry asked if authorization of 1/8-cent sales tax for ConnectSA would be on the November ballot. Mr. Walsh replied that the City Council would entertain that in the spring. Councilmember Perry noted that the City would incur an expense for two elections.

Councilmember Sandoval asked what the cost was to the City for the November 2018 election. Mrs. Vacek replied that it was approximately \$900,000.

Mayor Nirenberg stated that Pre-K 4 SA has been a success and has become the gold standard nationwide. He expressed his support for the program.

Councilmember Rocha Garcia moved to approve 24. Councilmember Sandoval seconded the motion to approve. The motion prevailed by the following vote:

#### **City Manager's Report**

**28.** City Manager's Report

Mr. Walsh reported that the Code Enforcement Division of the Development Services Department (DSD) was recently accredited by the International Accreditation Service. He noted that DSD, SAFD, and Metro Health have been recognized for International Accreditations by the International Code Council. He recognized Rhiannon Anderson, a San Antonio Probationary Police Officer, who will utilize her skills as a mother and a domestic violence survivor to help connect with the public. He presented a video in which KSAT TV spotlighted Officer Anderson.
