ORDINANCE

AUTHORIZING AN EXTENSION OF THE CITY OF SAN ANTONIO'S PARTICIPATION IN THE TRANSPORTATION SECURITY ADMINISTRATION'S NATIONAL EXPLOSIVES DETECTION CANINE TEAM PROGRAM AT THE SAN ANTONIO INTERNATIONAL AIRPORT THROUGH JUNE 30, 2020 WITH THE CITY TO BE REIMBURSED UP TO \$126,250.00 FOR THE FY 2020 AIRPORT OPERATING AND MAINTENANCE FUND.

WHEREAS, in November 2014, the City entered into a five-year reimbursement grant agreement with the Transportation Security Administration through Ordinance 2014-11-13-0913 for the City to provide explosives detection training for canines and personnel at San Antonio International Airport and for the TSA to reimburse certain operating expenses per canine team plus a stipend; and

WHEREAS, the City and TSA wish to retroactively extend the program from January 1, 2020 through June 30, 2020; and

WHEREAS, the City will be reimbursed up to \$126,250.00 to the FY 202 Airport Operating and Maintenance Fund of the Aviation Department for continued participation in this program; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or designee, or the Director of the San Antonio Aviation Department or designee, is authorized to execute all necessary documents to extend the participation in the National Explosives Detection Canine Team Program at the San Antonio International Airport Reimbursable Agreement Program with the Transportation Security Administration, with the City providing explosives detection training for canines and personnel and TSA reimbursing the City up to \$126,250.00 at the San Antonio International Airport for a period from January 1, 2020 through June 30, 2020.

SECTION 2. Upon execution of the extension, a final budget will be submitted by the San Antonio Department of Aviation, a new fund and internal order number will be created, into which the reimbursed amount not to exceed \$126,250.00 will be appropriated.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation

Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.
