### **Housing Protections**


- CPS Energy & SAWS are suspending disconnections until further notice.
- Bexar County and Texas Supreme Court issued a moratorium on eviction hearings.
- Tax Assessor cancelled property tax foreclosures for April and May.
- Fannie Mae and Freddie Mac suspended foreclosures and evictions of Enterprise-backed single-family mortgages for at least 60 days.
- The CARES Act included that any LIHTC project cannot issue a notice to vacate for 120 days and are prohibited from charging tenants any fees, penalties, or other charges related to nonpayment of rent during the period.

## Housing Protections Under Consideration

- Councilmember Roberto Trevino has requested that the City explore an ordinance that would require a landlord to provide tenants with a "notice of proposed eviction" at least 60 days before proceeding with a notice to vacate. The City of Austin has passed such an ordinance.
  - Challenges in terms of authority and enforcement.
  - Alternative, could be a contractual arrangement with landlords.

### **Requests for Housing Assistance**

- The City received over 5,300 requests for housing assistance last week.
  - Increased staff from 8 to 41.
  - Procured software to help process the applications more quickly.
  - Inquires as to the safety of the applicant/family to include food insecurity and domestic violence
  - Providing information on the unemployment filing process and the stimulus funds
- The utility assistance received 726 inquiries last week.



#### **Risk Mitigation Fund Policy**

- Adopted in October 2018.
- The fund supports relocation assistance, emergency housing assistance, and provides legal support through the Right to Counsel program.
- The FY2020 Adopted Budget provided \$1 million.
  - Current balance is \$350k.

#### **COVID 19 Emergency Housing Assistance Program**

- Same eligibility/allowance criteria prescribed in the Risk Mitigation Fund Policy.
- Allowable uses for the funds will be expanded to include groceries, fuel, and expenses related to internet access.
- Funds for rental, mortgage, internet, and utility assistance will be paid directly to the landlord, financial institution, internet provider, and utility provider.
- Assistance for groceries and gas will be distributed directly to the family.
  - Amount will be determined based on family size but will not exceed \$300.
- The program will sunset on July 31, 2020.
