

ORDINANCE 2020-04-16-0265

APPROVING THE ACCEPTANCE OF THE PROMISING PRACTICES GRANT IN AN AMOUNT UP TO \$25,000.00 FROM THE NATIONAL ASSOCIATION FOR COUNTY AND CITY HEALTH OFFICIALS TO SUPPORT THE PREVENTION OF CONGENITAL SYPHILIS.

WHEREAS, the National Association for County and City Health Officials (NACCHO), with support from the Centers for Disease Control and Prevention (CDC) Division of STD Prevention (DSTDP), solicited applications to fund at least five local health departments up to \$25,000.00 to implement and evaluate promising approaches to congenital syphilis prevention in November 2019; and

WHEREAS, priority for funding would go to projects that are ready for implementation, feasible across the country and promising to affect outcomes; and

WHEREAS, congenital syphilis is a disease that occurs when a pregnant person with syphilis passes the infection to the fetus during pregnancy; and

WHEREAS, from 2012 - 2017, Bexar County identified approximately 49 reported cases of congenital syphilis and in 2018 experienced a stark increase to 61 cases; and

WHEREAS, the San Antonio Metropolitan Health District's (Metro Health) Healthy Beats Program (HBP) was established in October 2013 in response to the increasing rates of congenital syphilis with the goal of providing prenatal case management to include providing and maintaining access to prenatal care, offering referral services for needs identified, and ensuring routine screening and treatment for syphilis; and

WHEREAS, Metro Heath proposed to use the funding to provide advertising, printing, and publications to educate the San Antonio community of the need for syphilis testing and adequate syphilis treatment for the prevention of congenital syphilis; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or designee, or the Director of the San Antonio Metropolitan Health District or designee, hereby authorized to accept grant funds in the amount not to exceed \$25,000.00 from the National Association of City and County Health Officials (NACCHO) for the Promising Practices Grant for a term of March 1, 2020 through March 28, 2021.

SECTION 2. The City Manager or designee, or the Director of the San Antonio Metropolitan Health District or designee, is further authorized to initiate, negotiate, and execute any and all necessary documents and grant contract to effectuate the acceptance of the grant referenced in Section 1 of this ordinance and to execute contract amendments pertaining to this contract to include a) carry-over funds,


when ascertained and approved by the funding agency through a revised notice of award; b) line item budget revisions authorized by the funding agency; c) modifications to the performance measures authorized by the funding agency and listed in the contract so long as the terms of the amendment stay within the general parameters of the intent of the grant; d) no cost extensions; e) amendments which will provide supplemental grant funds to the grant by the funding agency in an amount up to 20% of the total amount initially awarded to the grant; f) reimbursement increases of administrative funds for each participant served; g) amendments funding one time equipment purchases or defined program services; and h) changes in regulations mandated by the funding agency.

SECTION 3. Upon acceptance of this award, new funds and internal order numbers will be created, upon which the award amount will be appropriated from NACCHO. A final budget, which will include SAP Internal Orders and SAP GL Accounts, will be submitted by the San Antonio Metropolitan Health District upon award. The proposed budget, which is attached hereto and incorporated herein for all purposes as **Attachment I**, is approved and adopted for entry in the City books.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 5. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
