ACCEPTING A CONTRIBUTION FROM THE SOUTHWEST TEXAS REGIONAL ADVISORY COUNCIL IN AN AMOUNT UP TO \$384,478.00 TO THE SAN ANTONIO POLICE DEPARTMENT FOR THE FUSION MENTAL HEALTH UNIT TO IMPROVE OUTPATIENT SERVICES OF RESIDENTS WITH MENTAL ILLNESS WHO ARE REPEATEDLY TAKEN TO LOCAL HOSPITALS, AND APPROVING A PROGRAM BUDGET.

WHEREAS, the Southwest Texas Regional Advisory Council (STRAC) was established to facilitate the development, implementation, and operation of a regional comprehensive trauma and healthcare system; and

WHEREAS, in 2019 the STRAC provided funding for a six month pilot program called the Program for Intensive Care Coordination, to reduce the number of high-volume emergency detentions to local hospitals; and

WHEREAS, due to the success of the six month pilot program, additional funding has been provided for a twelve month period, to assist in decreasing the number of residents who are repeatedly emergency detained and taken to local hospitals; and

WHEREAS, the STRAC has up to \$384,478.00 available to pay for overtime to staff two San Antonio Police (SAPD) Department Fusion Mental Health Unit officers to assist with this program; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager and designee, and the Chief of SAPD and designee, are hereby authorized to accept a contribution in an amount up to \$384,478.00 from the STRAC that will be used by the SAPD Fusion Mental Health Unit, for overtime to staff two positions, and are further authorized to execute any and all documents necessary to effectuate said acceptance.

SECTION 2. Funds generated by this ordinance will be deposited into Fund 29817000, Internal Order 8170000000043 and General Ledger Account 6301120.

SECTION 3. Funds in the amount up to \$384,478.00 shall be appropriated in Fund 29817000, Internal Order 817000000043 per the table below:

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 5. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
