ORDINANCE

APPROVING A CONTRACT WITH GRANDE TRUCK CENTER TO PROVIDE THE ANIMAL CARE SERVICES DEPARTMENT WITH TWO ANIMAL TRANSPORT VANS FOR A TOTAL COST OF \$133,416.00. FUNDING IS AVAILABLE FROM THE EQUIPMENT RENEWAL AND REPLACEMENT FUND.

WHEREAS, a bid was submitted to provide the City of San Antonio's Animal Care Services Department with two replacement, animal transport vans to transport rescued animals; and

WHEREAS, Grande Truck Center submitted the low bid for a total cost of \$133,416.00; and

WHEREAS, funding for this purchase is available in the FY 2020 Equipment Renewal and Replacement Fund in the amount of \$133,416.00; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The bid submitted by Grande Truck Center for a total cost of \$133,416.00 is hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. The bid tabulation sheet is attached hereto and incorporated herein for all purposes as **Exhibit I**.

SECTION 2. Funding for this ordinance in the amount of \$133,416.00 is available in Fund 72001000, Cost Center 3503200001 and General Ledger Account 5709080 as part of the Fiscal Year 2020 Budget adopted by City Council.

SECTION 3. Payment is authorized to Grande Truck Center and should be encumbered with a purchase order.

SECTION 4. The financial allocations in this ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this ordinance.

SECTION 5. This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage.
