AN ORDINANCE 2020-05-14-0326

APPROVING THE APPLICATION AND ACCEPTANCE OF GRANT FUNDS IN THE AMOUNT OF \$2.331.581.00 FROM THE U.S. DEPARTMENT OF JUSTICE, OFFICE OF JUSTICE PROGRAMS, BUREAU OF JUSTICE ASSISTANCE FOR THE **CORONAVIRUS EMERGENCY SUPPLEMENTAL FUNDING PROGRAM FORMULA GRANT.**

WHEREAS, the U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance, is making \$850 million available nationwide through the Coronavirus Emergency Supplemental Funding (CESF) Program, which was established to assist local public safety agencies prevent, prepare for, and respond to the Covid-19 pandemic; and

WHEREAS, the CESF program is a formula grant in which funding is based upon the City's previous eligibility and participation in the fiscal year 2019 State and Local Edward Byrne Memorial Justice Assistance Grant program, and which is in an amount up to \$2,331,581.00; and

WHEREAS, the San Antonio Police Department will use funds from the grant to purchase equipment and supplies needed to continue operations during the current and any reoccurrence of the pandemic, and future pandemics and similar crises, and to strengthen its Continuity of Operations Plan; and

WHEREAS, the grant period, which is from January 20, 2020 through January 19, 2022, does not require an in-kind or cash match; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager and designee, and the Chief of Police and designee are hereby authorized to submit a grant application and accept grant funds in the amount up to \$2,331,581.00 from the Department of Justice, Office of Justice Programs, Bureau of Justice Assistance for the CESF program for preventing, preparing for, and responding to the Coronavirus pandemic for the grant period of January 20, 2020 to January 19, 2022.

SECTION 2. Upon acceptance of this award, new funds and internal order numbers will be created, upon which the award amount will be appropriated from the Department of Justice. A final budget, which will include SAP Internal Orders and SAP GL Accounts, will be submitted by the SAPD upon award. The proposed budget, which is attached hereto and incorporated herein for all purposes as **Exhibit A**, is approved and adopted for entry in the City books.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject

to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.


