## **ORDINANCE**

AUTHORIZING THE EXECUTION OF 13 LEASE RENEWALS FOR SPACE IN LA VILLITA, RESULTING IN A TOTAL OF \$439,169.00 TO BE DEPOSITED WITHIN THE GENERAL FUND DURING THE LEASE TERMS.

**WHEREAS**, in July 2014, the City of San Antonio released an RFP for several buildings within La Villita; and

WHEREAS, the intent of the RFP was to seek tenants that would enhance cultural tourism opportunities, promote greater community use, and highlight the artistic and historic aspects of La Villita; and

**WHEREAS**, the lease agreement provided for two, two-year renewal options with the exception of La Villita Café, which has one, two-year renewal option remaining; and

WHEREAS, City Council also authorized lease agreements with Liz Leatherbury d/b/a Bird & Pear for Building 10 in June 2017, and Karla Benavides d/b/a Huipil Market for Building 7 in June 2019; those leases expire on June 30, 2020, with two, one-year renewal options; and

**SECTION 1.** The City Manager or designee, or the Director of the Center City Development and Operations Department or designee, is authorized to execute the renewal of 13 existing lease agreements within La Villita. Copies of the Lease Amendments, in substantially final form, are attached hereto and incorporated herein for all purposes as **Attachment I**.

**SECTION 2.** Funds generated by this Ordinance will be deposited in Fund 11001000 per the table below.
