SUBMISSION OF GRANT APPLICATIONS AND AUTHORIZING ACCEPTANCE OF FUNDS FOR FAA AIP GRANTS FOR FOUR PROJECTS: AIRPORT MASTER PLAN UPDATE; AIRFIELD IMPROVEMENTS - PACKAGE & 7: **RUNWAY** 13L-31R MILL **OVERLAY:** AND TAXIWAY H **RECONSTRUCTION FOR A COMBINED TOTAL OF \$39,983,529.00; THE FAA** AIP GRANT AMOUNT OF \$29,387,492.00 AND THE CITY'S SHARE OF AUTOMATICALLY BY \$9.795.831.00 ARE TO BE **FUNDED** THE CORONAVIRUS AID, RELIEF, AND ECONOMIC SECURITY ACT ("CARES ACT"); NON-ELIGIBLE PROJECT COSTS ARE TO BE FUNDED FROM THE AIRPORT INTERIM FINANCING AND AIRPORT IMPROVEMENT & CONTINGENCY FUNDS IN THE AMOUNT OF \$800,206.00, AVAILABLE IN THE FY 2020 AVIATION CAPITAL BUDGET.

WHEREAS, the FAA through the Airport Improvement Program has designated the City to receive four FAA AIP Grants in the amount of \$29,387,492.00 to fund the Airport Master Plan Update, Airfield Improvements—Package 7, Runway 13L-31R Mill \$ Overlay and Taxiway H Reconstruction; and

**WHEREEAS,** the City's share of \$9,795,831.00 will be automatically funded by the Coronavirus Aid, Relief, and Economic Security Act ("CARES Act"); and

**WHEREAS,** funding for non-eligible project costs in the amount of \$800,206.00 is available in the FY 2020 Aviation Capital Budget; and

WHEREAS, it is now necessary to authorize the submission of the grant application, acceptance of the grant, and execution of the grant acceptance documents associated with the FAA AIP grant for the four projects; NOW THEREFORE:

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The City Manager or designee, or the Director of the Aviation Department or designee is authorized to submit and accept grant applications for up to \$29,387,492.00 from the Federal Aviation Administration for the Airport Improvement Program grants for four projects: Airport Master Plan Update; Airfield Improvements - Package 7; Runway 13L-31R Mill & Overlay; and, Taxiway H Reconstruction. The City's share of \$9,795,831.000 will be funded by the Coronavirus Relief, and Economic Security Act ('CARES Act''). Non-eligible project costs will be funded from the Airport Interim Financing and Airport Improvement & Contingency Fund in an amount of \$800,206.00, available in the FY 2020 Aviation Capital Budget.

SECTION 2. Upon approval of this ordinance, new funds and internal order numbers will be created, upon which the sum of up to \$29,387,492.00 from the FAA will be appropriated in said fund. A formal budget will also be provided once funds are awarded.

**SECTION 3.** The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 4.** This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
